There are two wetlands identified with the reviewed area (WA002 and WA003). WA002 is located in the southern section of the project and it is a freshwater scrub-shrub wetland depression that appears to be a historical depression not related to any drainages or channels in the area. WA002 exists entirely within the mapped Katy fine sandy loam, 0 to 1 percent slopes (Kf) soil type which is listed as containing hydric components and it does not exist within a designated FEMA floodplain (Zone X). WA002 measures approximately 0.363 acres in size and is dominated by hydrophytic vegetation including alligator-weed (*Alternanthera philoxeroides*), woodrush flat sedge (*Cyperus enterianus*), lamp rush (*Juncus effusus*), little false bluestem (*Schizachyrium scoparium*), and Chinese tallowtree (*Triadica sebifera*). WA002 does not appear to have a hydrologic connection to any Waters of the U.S.

WA003 is located in the northern section of the project and it is a freshwater emergent wetland depression that appears to be a man-made depression not related to any drainages or channels in the area. WA003 exists entirely within the mapped Aris-Gessner complex, 0 to 1 percent slopes (Ar) soil type which is listed as containing hydric components and it does not exist within a designated FEMA floodplain (Zone X). WA003 measures approximately 0.011 acres in size and is dominated by hydrophytic vegetation including valley redstem (*Ammannia coccinea*) and raven-foot sedge (*Carex crus-corvi*). WA003 does not appear to have a hydrologic connection to any Waters of the U.S.

Based on the topography and aerial imagery, the majority of the site is level, with gradual sloping south/west eventually entering HCFCD Unit No. U106-07-00 located east of the project limits. The wetland areas were identified using the 1987 Manual and 2010 Regional supplement: Atlantic and Gulf Coastal Plain Region, which requires that all three wetland criteria be present under normal circumstances for areas to be determined a wetland. The wetlands are depressional areas that experience seasonal hydrology during and after rain events, providing the conditions necessary for wetlands to establish. LIDAR indicates that WA002 has an approximate elevation of 123.83 MSL and WA003 has an approximate elevation of 124.52 MSL, while the FEMA 100-year floodplain elevation along the nearest water of the United States (Horsepen Creek) is 118.77 MSL.

The nearest Waters of the U.S. (Horsepen Creek) is located approximately one mile south of wetlands WA002 and WA003. Wetlands WA002 and WA003 are not located in reasonable close proximity to any Waters of the U.S. As such, under normal conditions in the hydrologic cycle, these wetlands would not be anticipated to share surface hydrology with the nearest Waters of the U.S. They are not tidal waters, nor part of a surface water tributary system to interstate water or navigable waters of the U.S. nor are they located "adjacent" (as defined in federal regulations) to any tributary waters; as such the wetlands have been determined to be "ISOLATED" as defined in federal regulations (33 CFR 330.2(e)).

"Adjacent" as per Federal regulations 33 CFR 328.3 is defined as "bordering, contiguous or neighboring." Wetlands separated from other Waters of the U.S. by man-made dikes or barriers, natural river berms, beach dunes and the like are 'adjacent wetlands'." The nearest Water of the U.S. to the wetlands is Horsepen Creek. These wetlands do not border nor are they contiguous (abutting) to Horsepen Creek. The wetlands are not neighboring Horsepen Creek as determined by the fact that they are, under normal conditions in the hydrologic cycle, not located in reasonably close proximity to another Water of the U.S. (and are not located in a contiguous or bordering landscape position) that would have shared surface hydrology with another Water of the U.S. during expected high flow (e.g. the 100-year floodplain). Nor is there any known demonstrable species ecological interconnection requiring the wetlands in question and the nearest Waters of the U.S. to spawn and/or fulfill their life cycle requirements. Wetlands WA002 and WA003 are physically separated from other Waters of the U.S. by geographic factors that do not allow the exchange of waters, via a confined surface hydrology connection during normal conditions and are not inseparably bound with Horsepen Creek.

"Isolated" waters as defined in 33 CFR 330.2 (e) is: "those non-tidal Waters of the U.S. that are: (1) not part of a surface tributary system to interstate or navigable Waters of the U.S.; and (2) not adjacent to such tributary waterbodies." The wetlands have been identified as wetlands (aquatic resources) that has been determined to be isolated.

"Waters of the U.S." are defined in 33 CFR 328.3 (a) 1 thru 7 which is addressed in the following. Due to the fact that these wetlands: (1) are not currently used, or were used in the past, nor susceptible to use for interstate or foreign commerce nor subject to the ebb and flow of the daily tide; (2) do not cross interstate or tribal boundaries; (3) the destruction of these wetlands is not expected to affect (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or (iii) current use or potential use for industrial purposes by industries in interstate commerce; (4) is not an impoundment of Waters of the U.S.; (5) is not part of a surface tributary system of (a) (1) through (4); (6) are not part of the territorial seas; and (7) are not adjacent to Waters of the U.S. identified in (a) (1) through (6) these areas (Wetlands WA002 and WA003) are not Waters of the U.S.

Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** There are two wetlands identified with the reviewed area (WA002 and WA003). WA002 is located in the southern section of the project and it is a freshwater scrub-shrub wetland depression that appears to be a historical depression not related to any drainages or channels in the area. WA002 exists entirely within the mapped Katy fine sandy loam, 0 to 1 percent slopes (Kf) soil type which is listed as containing hydric components and it does not exist within a designated FEMA floodplain



(Zone X). WA002 measures approximately 0.363 acres in size and is dominated by hydrophytic vegetation including alligator-weed (*Alternanthera philoxeroides*), woodrush flat sedge (*Cyperus enterianus*), lamp rush (*Juncus effusus*), little false bluestem (*Schizachyrium scoparium*), and Chinese tallowtree (*Triadica sebifera*). WA002 does not appear to have a hydrologic connection to any Waters of the U.S.

WA003 is located in the northern section of the project and it is a freshwater emergent wetland depression that appears to be a man-made depression not related to any drainages or channels in the area. WA003 exists entirely within the mapped Aris-Gessner complex, 0 to 1 percent slopes (Ar) soil type which is listed as containing hydric components and it does not exist within a designated FEMA floodplain (Zone X). WA003 measures approximately 0.011 acres in size and is dominated by hydrophytic vegetation including valley redstem (*Ammannia coccinea*) and raven-foot sedge (*Carex crus-corvi*). WA003 does not appear to have a hydrologic connection to any Waters of the U.S.

Based on the topography and aerial imagery, the majority of the site is level, with gradual sloping south/west eventually entering HCFCD Unit No. U106-07-00 located east of the project limits. The wetland areas were identified using the 1987 Manual and 2010 Regional supplement: Atlantic and Gulf Coastal Plain Region, which requires that all three wetland criteria be present under normal circumstances for areas to be determined a wetland. The wetlands are depressional areas that experience seasonal hydrology during and after rain events, providing the conditions necessary for wetlands to establish. LIDAR indicates that WA002 has an approximate elevation of 123.83 MSL and WA003 has an approximate elevation of 124.52 MSL, while the FEMA 100-year floodplain elevation along the nearest water of the United States (Horsepen Creek) is 118.77 MSL.

The nearest Waters of the U.S. (Horsepen Creek) is located approximately one mile south of wetlands WA002 and WA003. Wetlands WA002 and WA003 are not located in reasonable close proximity to any Waters of the U.S. As such, under normal conditions in the hydrologic cycle, these wetlands would not be anticipated to share surface hydrology with the nearest Waters of the U.S. They are not tidal waters, nor part of a surface water tributary system to interstate water or navigable waters of the U.S. nor are they located "adjacent" (as defined in federal regulations) to any tributary waters; as such the wetlands have been determined to be "ISOLATED" as defined in federal regulations (33 CFR 330.2(e)).

"Adjacent" as per Federal regulations 33 CFR 328.3 is defined as "bordering, contiguous or neighboring." Wetlands separated from other Waters of the U.S. by man-made dikes or barriers, natural river berms, beach dunes and the like are 'adjacent wetlands'." The nearest Water of the U.S. to the wetlands is Horsepen Creek. These wetlands do not border nor are they contiguous (abutting) to Horsepen Creek. The wetlands are not neighboring Horsepen Creek as determined by the fact that they are, under normal conditions in the hydrologic cycle, not located in reasonably close proximity to another Water of the U.S. (and are not located in a contiguous or bordering landscape position) that would have shared surface hydrology with another Water of the U.S. during expected high flow (e.g. the 100-year floodplain). Nor is there any known demonstrable species ecological interconnection requiring the wetlands in question and the nearest Waters of the U.S. to spawn and/or fulfill their life cycle requirements. Wetlands WA002 and WA003 are physically separated from other Waters of the U.S. by geographic factors that do not allow the exchange of waters, via a confined surface hydrology connection during normal conditions and are not inseparably bound with Horsepen Creek.

"Isolated" waters as defined in 33 CFR 330.2 (e) is: "those non-tidal Waters of the U.S. that are: (1) not part of a surface tributary system to interstate or navigable Waters of the U.S.; and (2) not adjacent to such tributary waterbodies." The wetlands have been identified as wetlands (aquatic resources) that has been determined to be isolated.

"Waters of the U.S." are defined in 33 CFR 328.3 (a) 1 thru 7 which is addressed in the following. Due to the fact that these wetlands: (1) are not currently used, or were used in the past, nor susceptible to use for interstate or foreign commerce nor subject to the ebb and flow of the daily tide; (2) do not cross interstate or tribal boundaries; (3) the destruction of these wetlands is not expected to affect (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or (iii) current use or potential use for industrial purposes by industries in interstate commerce; (4) is not an impoundment of Waters of the U.S.; (5) is not part of a surface tributary system of (a) (1) through (4); (6) are not part of the territorial seas; and (7) are not adjacent to Waters of the U.S. identified in (a) (1) through (6) these areas (Wetlands WA002 and WA003) are not Waters of the U.S.
