C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The delineated aquatic features present within the subject site are man-made drainage ditches, excavated wholly in and draining only uplands, and do not carry relatively permanent water flow. Therefore, based on a review of multiple exhibits including but not limited to topographical maps, historical aeriels, the U.S. Fish and Wildlife Service National Wetland Inventory map, and the U.S. Department of Agriculture soil survey map data, we determined the ditches neither re-route a tributary nor extend the ordinary high water mark of a tributary. Therefore the ditches are not waters of the United States subject to regulation under Section 404 of the Clean Water Act. A Department of the Army permit is not required to discharge dredged and/or fill material onto the subject site.
