Summarize rationale supporting conclusion that wetland is "adjacent": The subject site contains seven (7) wetlands, for a total of approximately 4.36 acres (Wetland 1A – approximately 0.18 acre, Wetland 1B – approximately 0.23 acre, Wetland 2A – approximately 0.17 acre, Wetland 2B - approximately 0.23 acre, Wetland 3 – approximately 0.26 acre, Wetland 4A – approximately 1.52 acre, and Wetland 4B – approximately 1.78 acre). All of these wetlands are located within the 100-year flood plain of Cedar Bayou, which is neighboring and therefore adjacent to a TNW. Therefore, per 33 CFR 328.3(a)(7), Wetlands 1A through 4B are subject to Section 404 of the Clean Water Act.

Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Stream 01 (Water Oak Gully), an approximately 3,320-linear-foot tributary of Cedar Bayou, is subject to the daily tidal ebb and flow. Therefore, per 33 CFR 328.3(a)(1) Stream 01 is subject to Section 404 of the Clean Water Act, and per 33 CFR 329.4 is also subject to Section 10 of the Rivers and Harbors Act of 1899.
