### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Multiple exhibits were reviewed including but not limited to topographical maps, historical aerials, the USFWS NWI map, and the Web Soil Survey map. The USGS topo quad depicts the subject site as mostly flat, within the quad map resolution; no aquatic features are depicted on the quad map. The subject site does not lie within the 1% annual flood risk zone (100-year flood plain) of the Gulf of Mexico, the nearest water body. The FWS NWI Mapper identifies the subject site as Pf (Farmed wetland). And the National Cooperative Soil Survey (NCSS) identifies one (1) soil order present within the subject site: League clay, 0 to 1% slopes, rarely flooded (10% hydric associated

with the Beaumont soil inclusion). This soil order is listed on the National List of Hydric Soils for Chambers County in Texas. Three (3) water-filled depressions were identified within the subject site. These features resulted from the use of explosives in the 1940's to conduct seismic testing and are therefore artificially derived. Water within these features is artificial maintained due to irrigation conducted to produce rice within the immediated adjacent areas. According to the Chambers County soil survey, groundwater is typically found at a depth of approximately 36 inches within the League clay soil series. The area would revert to upland if the irrigation ceased. As such, none of these features would generally be considered a water of the U.S.
