Based on a review of Corps databases, historical jurisdictional determinations with permit actions or alleged violations (SWG 2010-01129, SWG 2011-00426, and SWG 2011-00697), Pine Gully is a tidally-influenced waterway that flows directly into Galveston Bay. Therefore, Pine Gully at this juncture and Taylor Bayou are navigable waters of the United States subject to §404 of the Clean Water Act and §10 of the Rivers and Harbors Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Explain: There is one isolated wetland on the project site totaling approximately 0.14 acre. The wetland was identified using the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual, which requires a dominance of hydrophytic vegetation, wetland hydrology indicators, and hydric soils, under normal conditions. W005 is appx 0.14 acre in size. The nearest water of the United States is Pine Gully located approximately 0.43 aerial mile

south of the project site. Pine Gully is a Traditional Navigable Water. According to the FEMA floodplain map, the subject wetland is located outside the 100-year floodplain of any water of the United States. As such, it is located outside the anticipated high flow of any water of the US. Based on the 6 July 2017 site visit and off-site review, it has been verified that this wetland does not have a confined hydrological surface connection to any water of the United States, nor is it "inseparably bound" to any waters of the United States under normal hydrologic conditions.

-Based on off-site data and on-site data collected during the site visit conducted 6 July 2017, there are no known hydrological connections between the wetland and Pine Gully or any other water of the United States.

-There are no confined surface hydrologic connections between W005 and any water of the United States.

-W005 is isolated and is not a water of the United States, as defined in 33 CFR 328.3(a). It is not currently used, was not used in the past, nor is it susceptible to use for interstate or foreign commerce. The destruction of the subject wetland would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: There is one isolated wetland on the project site totaling approximately 0.14 acre. The wetland was identified using the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland

Delineation Manual, which requires a dominance of hydrophytic vegetation, wetland hydrology indicators, and hydric soils, under normal conditions. W005 is appx 0.14 acre in size. The nearest water of the United States is Pine Gully located approximately 0.43 aerial mile south of the project site. Pine Gully is a Traditional Navigable Water. According to the FEMA floodplain map, the subject wetland is located outside the 100-year floodplain of any water of the United States. As such, it is located outside the anticipated high flow of any water of the US. Based on the 6 July 2017 site visit and off-site review, it has been verified that this wetland does not have a confined hydrological surface connection to any water of the United States, nor is it "inseparably bound" to any waters of the United States under normal hydrologic conditions.

-Based on off-site data and on-site data collected during the site visit conducted 6 July 2017, there are no known hydrological connections between the wetland and Pine Gully or any other water of the United States.

-There are no confined surface hydrologic connections between W005 and any water of the United States.

-W005 is isolated and is not a water of the United States, as defined in 33 CFR 328.3(a). It is not currently used, was not used in the past, nor is it susceptible to use for interstate or foreign commerce. The destruction of the subject wetland would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce.

-W005 is not subject to the ebb and flow of the daily tide.

-W005 does not cross interstate or tribal boundaries.

-W005 is not an impoundment of a water of the United States.

-W005 is not part of a surface tributary system of any of the above.

-W005 is not part of the territorial seas.

-W005 is not adjacent (bordering, contiguous, or neighboring) as defined by 33CFR 328.3(c) to any waters of the U.S.

-W005 has been determined not to be "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require any of the subject wetlands and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements.

-W005 is an isolated wetland as defined in 33 CFR 330.2(e): those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States, and are not adjacent to such tributary waterbodies. It is located outside of the 100-year floodplain of any water of the United States and does not have a confined hydrological surface connection to any water of the United States.

-W005 has no known nexus to interstate commerce. We determined W005 is not a water of the United States and is not subject to Section 404 of the Clean Water Act.

In conclusion, it is SWG's draft determination that W005 totaling appx 0.14 acre is "isolated" and lacks a nexus to interstate commerce. As such, this wetlands is not a water of the United States subject to Section 404 of the Clean Water Act.
