the 1987 Corps of Engineers Wetland Delineation Manual which under normal circumstances exhibits a dominance of hydrophytic vegetation, wetland hydrology indicators, and hydric soils. The nearest known water of the United States is Whiteoak Bayou, a tributary that flows into Buffalo Bayou. Wetland1 is located approximately 4,400 feet east of Whiteoak Bayou.

Based on a review of off-site information and the site visit conducted 19 April 2017, there are no known surface hydrological connection between the wetland and any waters of the U.S. A review of the FEMA map showed the wetland is located outside of the FEMA 100-year floodplain of Whiteoak Bayou. The wetland is not adjacent to any waters of the United States as defined by 33 CFR 328.3(c).

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Wetland1 have been determined not to be "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this geographic region that require both the subject wetland and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements.

In conclusion, it is SWG draft determination that the wetland on the tract, approximately 0.005 acre, is an isolated (as per federal regulation) wetland that does not possess any known nexus to interstate commerce. As such, is not subject to federal regulation under Section 404 of the Clean Water Act.
