Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. surrounded by uplands. The wetlands were identified using the Atlantic and Gulf Coastal Plain Region Supplement of the 1987 Corps of Engineers Wetland Delineation Manual which under normal circumstances exhibits a dominance of hydrophytic vegetation, wetland hydrology indicators, and hydric soils. The nearest potential water of the United States is the upper ephemeral reaches of Seals Gully, a tributary that flows into Cypress Creek. Wetland 1 is located approximately 2700 feet from the northern reach of the potential jurisdictional portion of Seals Gully and greater than 18,000' from the 2nd order and mapped more seasonally flow portion of Seals Gully. Wetland 2 and Wetland 3 are also located greater than 18,000' from a known water of the US. Wetland 2 is located approximately 2900 feet north of Seals Gully. Wetland 3 is located approximately 3000 feet north of Seals Gully.

Based on a review of off-site information and the site visit conducted 19 April 2017, there are no known surface hydrological connections between the wetlands and the nearest waters of the US. A review of the FEMA map showed the wetlands located above the elevation and outside any mapped FEMA 100-year floodplain. The wetlands are not adjacent to any waters of the United States as defined by 33 CFR 328.3(c).

Wetland 1, Wetland 2, and Wetland 3 are "isolated" as defined in 33 CFR 330.2(e) as those non-tidal waters that are: (1) Not part of a surface tributary system to interstate or navigable waters of the United States; and (2) Not adjacent to such tributary waterbodies.

- These wetlands are not subject to the ebb and flow of the daily tide, nor are they part of a territorial sea.

C. SIGNIFICANT NEXUS DETERMINATION

- These wetlands are not subject to the ebb and flow of the daily tide, nor are they part of a territorial sea.
- They do not cross interstate or tribal boundaries.
- The wetlands are "isolated" and are not currently used, were not used in the past, nor are they susceptible to use in interstate or foreign commerce. They do not affect (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or, (iii) current use or potential use for industrial purposes by industries in interstate commerce.
- These wetlands are not impoundments of waters of the United States.
- The wetlands are not, nor were they ever, part of a surface tributary system of previous waters.
- These wetlands are not "adjacent" (as defined in federal regulations) to any other water of the US previously identified.
- The wetlands have been determined not to be "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this geographic region that require both the subject wetlands and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements.

In conclusion, it is SWG draft determination that the three wetlands on the tract totaling approximately 1.61 acres are isolated (as per federal regulation) wetlands that do not possess any known nexus to interstate commerce. As such, are not subject to federal regulation under Section 404 of the Clean Water Act.
