- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: There are five isolated wetlands on the project site totlaing appx 1.6+ acres. The wetlands were identified using the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual, which requires a dominance of hydrophytic vegetation, wetland hydrology indicators, and hydric soils, under normal conditions.
Wetland 1 is appx 0.75 acre in size, Wetland 2 is appx 0.7 acre in size, Wetland 7 is appx 0.02 acre, Wetland 8 is appx 0.15

acre in size and Wetland 10 is appx 0.01 acre in size. The nearest water of the United States is Langham Creek located approximately 0.8 aerial miles southwest of the project site. The nearest Traditional Navigable Water is the navigable portion of Cypress Creek located approximately 14.+ aerial miles northeast of the project site. According to the FEMA floodplain map, all of these subject wetlands are located outside the 100-year floodplain of any water of the United States. As such, they are located outside the anticipated high flow of any water of the US. Based on the 20 April 2017 site visit and off-site review it has been verified that none of these wetlands have a confined hydrological surface connection to any water of the United States, nor are they "inseparably bound" to any waters of the United States under normal hydrologic conditions.

- Based on off-site data and on-site data collected during the site visit conducted 20 April 2017, there are no known hydrological connections between the wetlands (Wetlands 1, 2, 7, 8, or 10) and Cypress Creek or any other water of the United States.
- There are no confined surface hydrologic connections between the wetlands (Wetlands 1, 2, 7, 8, or 10) and any water of the United States.
- Wetlands 1, 2, 7, 8, and 10 are isolated and are not waters of the United States, as defined in 33 CFR 328.3(a). They are not currently used, were not used in the past, nor are they susceptible to use for interstate or foreign commerce. The destruction of these subject wetlands would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce.
- Wetlands 1, 2, 7, 8, and 10 are not subject to the ebb and flow of the daily tide.
- Wetlands 1, 2, 7, 8, and 10 do not cross interstate or tribal boundaries.
- Wetlands 1, 2, 7, 8, and 10 are not impoundments of a water of the United States.
- Wetlands 1, 2, 7, 8, and 10 are not part of a surface tributary system of any of the above.
- Wetlands 1, 2, 7, 8, and 10 are not part of the territorial seas.
- Wetlands 1, 2, 7, 8, and 10 are not adjacent (bordering, contiguous, or neighboring) as defined by 33CFR 328.3(c) to any waters of the U.S.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: There are five isolated wetlands on the project site totlaing appx 1.6+ acres. The wetlands were identified using the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation

Manual, which requires a dominance of hydrophytic vegetation, wetland hydrology indicators, and hydric soils, under normal conditions. Wetland 1 is appx 0.75 acre in size, Wetland 2 is appx 0.7 acre in size, Wetland 7 is appx 0.02 acre, Wetland 8 is appx 0.15 acre in size and Wetland 10 is appx 0.01 acre in size. The nearest water of the United States is Langham Creek located approximately 0.8 aerial miles southwest of the project site. The nearest Traditional Navigable Water is the navigable portion of Cypress Creek located approximately 14.+ aerial miles northeast of the project site. According to the FEMA floodplain map, all of these subject wetlands are located outside the 100-year floodplain of any water of the United States. As such, they are located outside the anticipated high flow of any water of the US. Based on the 20 April 2017 site visit and off-site review it has been verified that none of these wetlands have a confined hydrological surface connection to any water of the United States, nor are they “inseparably bound” to any waters of the United States under normal hydrologic conditions.

-Based on off-site data and on-site data collected during the site visit conducted 20 April 2017, there are no known hydrological connections between the wetlands (Wetlands 1, 2, 7, 8, or 10) and Cypress Creek or any other water of the United States.

-There are no confined surface hydrologic connections between the wetlands (Wetlands 1, 2, 7, 8, or 10) and any water of the United States.

-Wetlands 1, 2, 7, 8, and 10 are isolated and are not waters of the United States, as defined in 33 CFR 328.3(a). They are not currently used, were not used in the past, nor are they susceptible to use for interstate or foreign commerce. The destruction of these subject wetlands would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce.

-Wetlands 1, 2, 7, 8, and 10 are not subject to the ebb and flow of the daily tide.

-Wetlands 1, 2, 7, 8, and 10 do not cross interstate or tribal boundaries.

-Wetlands 1, 2, 7, 8, and 10 are not impoundments of a water of the United States.

-Wetlands 1, 2, 7, 8, and 10 are not part of a surface tributary system of any of the above.

-Wetlands 1, 2, 7, 8, and 10 are not part of the territorial seas.

-Wetlands 1, 2, 7, 8, and 10 are not adjacent (bordering, contiguous, or neighboring) as defined by 33CFR 328.3(c) to any waters of the U.S.

-Wetlands 1, 2, 7, 8, and 10 have been determined not to be "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require any of the subject wetlands and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements.

-Wetlands 1, 2, 7, 8, and 10 are isolated wetlands as defined in 33 CFR 330.2(e): those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States, and are not adjacent to such tributary waterbodies. They are all located outside of the 100-year floodplain of any water of the United States and do not have a confined hydrological surface connection to any water of the United States.

In conclusion, it is SWG's draft determination that the five wetlands on the tract totaling appx 1.6+ acres are "isolated" and lack a nexus to interstate commerce. As such, these wetlands are not waters of the United States subject to Section 404 of the Clean Water Act.
