### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD: Three existing drainage ditches will be cleaned and regraded in Falfurrias, Brooks County, Texas. The first location is at the intersection of West Travis Street and U.S.**



281 frontage road. Approximately 375 linear feet (lf) of drainage ditch along East Travis Street and approximately 376 lf of drainage ditch along U.S. 281 frontage road/North Saint Mary Street will be cleaned and regraded. The second location is on the east side of U.S. 281 and approximately 0.15 mile north of East Noble Street. Approximately 1,000 lf of drainage ditch running west to east from U.S. 281 to Palo Blanco Creek will be cleaned and regraded. Palo Blanco Creek will not be disturbed by the regrading of the drainage ditch by terminating the project above the ordinary high water mark of the creek. The third location is on the east side of U.S. 281 and approximately 0.2 mile north of CR 303. Approximately 970 lf of the existing drainage ditch that drains east to an existing pond will be cleaned and regraded. All drainage ditches, total approximately 2,720 linear feet, were excavated in uplands and receive water form overland flow generated from precipitation. The National Wetland Inventory indicated no wetlands in or surrounding the drainage ditches.
