- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: Within this 69-acre project area, there were 15 wetland polygons and five open water polygons identified. These aquatic features total approximately 30.20 acres. The wetlands were identified using the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual, which requires a dominance of hydrophytic vegetation, wetland hydrology indicators, and hydric soils, under normal conditions. These wetlands are located within a

historically topographically low area surrounded by higher elevation features. The hydrology of the area has been extensively anthropogenically altered over time from an mapped isolated linear ephemeral feature in the oldest topographic maps, to changes in "headwater" origination features and multiple occasions over time where the area and off-site features were channelized and or re-directed, ponds/lakes excavated. The area is surrounded by higher elevations. The principal source of hydrology appears be largely associated with water backing up in the linear feature and the ponds/lakes and supporting the wetland features. The aquatic resources in review provide stormwater storage; collecting water that backs up across the project area until it can eventually spill over an (off site) high point that was partially carved into the elevated landscape into an upland manmade drainage ditch. This drainage ditch then connects to another constructed basin and eventually flows back into another upland manmade drainage ditch for approximately 2.1 miles before it intersects connects with Spring Creek. The aquatic features in review do NOT extend the Ordinary High Water Mark (OHWM) of Spring Creek. Although the site substrate includes soils that may have hydric minor components, it is primarily the bowl-like surrounding topography in a receiving landscape positions that affects the hydrology on the site such that wetlands develop. The nearest known water of the United States (WOUS) is Spring Creek (a Relatively Permanent Water (RPW)) which is located approximately 2.1 miles north of the site's aquatic features. It is separated from the site by uplands and roadside upland manmade drainage ditches, other excavated detention features and a natural, elevated berm that over spills upon rain events to an upland drainage ditch south of the intersection of Liberty Lane and Hicks Street.

According to the FEMA floodplain information all of the subject wetlands are located above the 100-year floodplain elevation (above any anticipated high flow of the nearby waterway) of any known WOUS. These features do not have a confined hydrological surface connection to any WOUS and are not "inseparably bound" to any WOUS under normal hydrologic conditions.

- Based on off-site data and on-site data collected during the site visit conducted 26 October 2017, there are no known surface hydrological connections between any of these subject aquatic features in review and any WOUS.
- The wetlands (as well as the open water areas) are located in an "isolated" geomorphic position and are not currently used, were not used in the past, nor are they susceptible to use for interstate or foreign commerce.
 - None of these aquatic features are subject to the ebb and flow of the daily tide.
 - These wetlands and waters do not cross interstate or tribal boundaries.
- The destruction of the subject wetlands (intrastate wetlands) and/or waters would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce.
 - None of these wetlands and waters are impoundments of a WOUS.
 - None of these wetlands and waters are part of a surface tributary system of any of the above.
 - None of these wetlands and waters are part of the territorial seas.
- None of these wetlands (nor waters) are located "adjacent" {(bordering, contiguous, or neighboring) as defined by 33CFR 328.3(c)} geomorphic position in relationship to any WOUS.
- None of these aquatic features are "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require any of the subject wetlands and waters along with the nearest waterbody to fulfill spawning and/or life cycle requirements.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Within this 69-acre project area, there were 15 wetland polygons and five open water polygons identified. These aquatic features total approximately 30.20 acres. The wetlands were identified using the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual, which requires a dominance of hydrophytic vegetation, wetland hydrology indicators, and hydric soils, under normal conditions. These wetlands are located within a historically topographically low area surrounded by higher elevation

features. The hydrology of the area has been extensively anthropogenically altered over time from an mapped isolated linear ephemeral feature in the oldest topographic maps, to changes in “headwater” origination features and multiple occasions over time where the area and off-site features were channelized and or re-directed, ponds/lakes excavated. The area is surrounded by higher elevations. The principal source of hydrology appears be largely associated with water backing up in the linear feature and the ponds/lakes and supporting the wetland features. The aquatic resources in review provide stormwater storage; collecting water that backs up across the project area until it can eventually spill over an (off site) high point that was partially carved into the elevated landscape into an upland manmade drainage ditch. This drainage ditch then connects to another constructed basin and eventually flows back into another upland manmade drainage ditch for approximately 2.1 miles before it intersects connects with Spring Creek. The aquatic features in review do NOT extend the OHWM of Spring Creek. Although the site substrate includes soils that may have hydric minor components, it is primarily the bowl-like surrounding topography in a receiving landscape positions that affects the hydrology on the site such that wetlands develop. The nearest known water of the United States (WOUS) is Spring Creek (a Relatively Permanent Water (RPW)) which is located approximately 2.1 miles north of the site’s aquatic features. It is separated from the site by uplands and roadside upland manmade drainage ditches, other excavated detention features and a natural, elevated berm that over spills upon rain events to an upland drainage ditch south of the intersection of Liberty Lane and Hicks Street.

According to the FEMA floodplain information all of the subject wetlands are located above the 100-year floodplain elevation (above any anticipated high flow of the nearby waterway) of any known WOUS. These features do not have a confined hydrological surface connection to any WOUS and are not “inseparably bound” to any WOUS under normal hydrologic conditions.

- Based on off-site data and on-site data collected during the site visit conducted 26 October 2017, there are no known surface hydrological connections between any of these subject aquatic features in review and any WOUS.
- The wetlands (as well as the open water areas) are located in an "isolated" geomorphic position and are not currently used, were not used in the past, nor are they susceptible to use for interstate or foreign commerce.
- None of these aquatic features are subject to the ebb and flow of the daily tide.
- These wetlands and waters do not cross interstate or tribal boundaries.
- The destruction of the subject wetlands (intrastate wetlands) and/or waters would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce.
- None of these wetlands and waters are impoundments of a WOUS.
- None of these wetlands and waters are part of a surface tributary system of any of the above.
- None of these wetlands and waters are part of the territorial seas.
- None of these wetlands (nor waters) are located "adjacent" {(bordering, contiguous, or neighboring) as defined by 33CFR 328.3(c)} geomorphic position in relationship to any WOUS.
- None of these aquatic features are "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require any of the subject wetlands and waters along with the nearest waterbody to fulfill spawning and/or life cycle requirements.

In conclusion, it is SWG's draft determination that there are 15 wetland polygons and 5 other open waters on the tract totaling approximately 30.20 acres. These aquatic features are "isolated" and lack a nexus to interstate commerce. As such, they would not be WOUS subject to Section 404 of the Clean Water Act.
