- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: Wetland B is located in the southeast section of the project area. Wetland B is a freshwater emergent wetland depression area that has formed from the lack of drainage in the area. The source of hydrology for Wetland B appears to be in the form of rainfall and surface runoff. Wetland B exist entirely with the mapped VirA soil type which is listed as not containing hydric components in Harris County and it does not exist within a designated FEMA floodplain (Zone X).

Wetland B measures approximately 0.04 acres in size and is dominated by hydrophytic vegetation including Cherokee sedge and oppositleaf spotflower. Wetland B does not appear to have a hydrologic connection to any Water of the U.S.

Based on the topography and aerial imagery, the majority of the site is level, with gradual sloping west/southwest towards Luce Bayou (HCFCD Unit No. S100-00-00) located west of the project site. The wetland is identified using the 1987 Manual regional supplement: Atlantic and Gulf Coastal Plain Region, which requires that all three wetland criteria be present under normal circumstances for areas to be determined a wetland. The wetland is a depressional area that experiences seasonal hydrology during and after rain events, providing the conditions necessary for wetlands to establish.

The nearest Waters of the U.S. (Luce Bayou) is located approximately 0.75 miles east of Wetland B. Wetland B is not located in reasonable close proximity to any Waters of the U.S. As such, under normal conditions in the hydrologic cycle, this wetland is not anticipated to share surface hydrology with the nearest Waters of the U.S. Wetland B is not a tidal water, nor part of a surface water tributary system to interstate water or navigable waters of the U.S. nor are they located "adjacent" (as defined in federal regulations) to any tributary waters; as such the wetland has been determined to be "ISOLATED" as defined in federal regulations (33 CFR 330.2(e)).

"Adjacent" as per Federal regulations 33 CFR 328.3 is defined as "bordering, contiguous or neighboring." Wetlands separated from other Waters of the U.S. by man-made dikes or barriers, natural river berms, beach dunes and the like are 'adjacent wetlands.'" The nearest Waters of the U.S. to the wetlands is Luce Bayou. Wetland B does not border nor is it contiguous (abutting) to Luce Bayou. The wetland is not neighboring Luce Bayou as determined by the fact that they are, under normal conditions in the hydrologic cycle, not located in reasonably close proximity to another Water of the U.S. (and are not located in a contiguous or bordering landscape position) that would have shared surface hydrology with another Water of the U.S. during expected high flow (e.g. the 100-year floodplain). Nor is there any known demonstrable species ecological interconnection requiring both the wetlands in question and the nearest Waters of the U.S. to spawn and/or fulfill their life cycle requirements. Wetland B is physically separated from other Waters of the U.S. by geographic factors that do not allow the exchange of waters, via a confined surface hydrology connection during normal conditions and are not inseparably bound with Luce Bayou.

"Isolated" waters as defined in 33 CFR 330.2 (e) is: "those non-tidal Waters of the U.S. that are: (1) not part of a surface tributary system to interstate or navigable Waters of the U.S.; and (2) not adjacent to such tributary waterbodies." Both wetlands have been identified as wetlands (aquatic resources) that have been determined to be isolated.

"Waters of the U.S." are defined in 33 CFR 328.3 (a) 1 thru 7 which is addressed in the following. Due to the fact that these wetlands: (1) are not currently used, or were used in the past, nor susceptible to use for interstate or foreign commerce nor subject to the ebb and flow of the daily tide; (2) do not cross interstate or tribal boundaries; (3) the destruction of these wetlands is not expected to affect (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or (iii) current use or potential use for industrial purposes by industries in interstate commerce; (4) are not impoundments of Waters of the U.S.; (5) are not part of a surface tributary system of (a) (1) through (4); (6) are not part of the territorial seas; and (7) are not adjacent to Waters of the U.S. identified in (a) (1) through (6) this (Wetland and B) is not Waters of the U.S.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland B is located in the southeast section of the project area. Wetland B is a freshwater emergent wetland depression area that has formed from the lack of drainage in the area. The source of hydrology for Wetland B appears to be in the form of rainfall and surface runoff. Wetland B exist entirely with the mapped VirA soil type which is listed as not containing hydric components in Harris County and it does not exist within a designated FEMA floodplain (Zone X). Wetland B measures

approximately 0.04 acres in size and is dominated by hydrophytic vegetation including Cherokee sedge and oppositeleaf spotflower. Wetland B does not appear to have a hydrologic connection to any Water of the U.S.

Based on the topography and aerial imagery, the majority of the site is level, with gradual sloping west/southwest towards Luce Bayou (HCFCD Unit No. S100-00-00) located west of the project site. The wetland is identified using the 1987 Manual regional supplement: Atlantic and Gulf Coastal Plain Region, which requires that all three wetland criteria be present under normal circumstances for areas to be determined a wetland. The wetland is a depressional area that experiences seasonal hydrology during and after rain events, providing the conditions necessary for wetlands to establish.

The nearest Waters of the U.S. (Luce Bayou) is located approximately 0.75 miles east of Wetland B. Wetland B is not located in reasonable close proximity to any Waters of the U.S. As such, under normal conditions in the hydrologic cycle, this wetland is not anticipated to share surface hydrology with the nearest Waters of the U.S. Wetland B is not a tidal water, nor part of a surface water tributary system to interstate water or navigable waters of the U.S. nor are they located "adjacent" (as defined in federal regulations) to any tributary waters; as such the wetland has been determined to be "ISOLATED" as defined in federal regulations (33 CFR 330.2(e)).

"Adjacent" as per Federal regulations 33 CFR 328.3 is defined as "bordering, contiguous or neighboring." Wetlands separated from other Waters of the U.S. by man-made dikes or barriers, natural river berms, beach dunes and the like are 'adjacent wetlands'." The nearest Waters of the U.S. to the wetlands is Luce Bayou. Wetland B does not border nor is it contiguous (abutting) to Luce Bayou. The wetland is not neighboring Luce Bayou as determined by the fact that they are, under normal conditions in the hydrologic cycle, not located in reasonably close proximity to another Water of the U.S. (and are not located in a contiguous or bordering landscape position) that would have shared surface hydrology with another Water of the U.S. during expected high flow (e.g. the 100-year floodplain). Nor is there any known demonstrable species ecological interconnection requiring both the wetlands in question and the nearest Waters of the U.S. to spawn and/or fulfill their life cycle requirements. Wetland B is physically separated from other Waters of the U.S. by geographic factors that do not allow the exchange of waters, via a confined surface hydrology connection during normal conditions and are not inseparably bound with Luce Bayou.

"Isolated" waters as defined in 33 CFR 330.2 (e) is: "those non-tidal Waters of the U.S. that are: (1) not part of a surface tributary system to interstate or navigable Waters of the U.S.; and (2) not adjacent to such tributary waterbodies." Both wetlands have been identified as wetlands (aquatic resources) that have been determined to be isolated.

"Waters of the U.S." are defined in 33 CFR 328.3 (a) 1 thru 7 which is addressed in the following. Due to the fact that these wetlands: (1) are not currently used, or were used in the past, nor susceptible to use for interstate or foreign commerce nor subject to the ebb and flow of the daily tide; (2) do not cross interstate or tribal boundaries; (3) the destruction of these wetlands is not expected to affect (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or (iii) current use or potential use for industrial purposes by industries in interstate commerce; (4) are not impoundments of Waters of the U.S.; (5) are not part of a surface tributary system of (a) (1) through (4); (6) are not part of the territorial seas; and (7) are not adjacent to Waters of the U.S. identified in (a) (1) through (6) this (Wetland and B) is not Waters of the U.S.
