Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: There is one isolated wetland (Wetland A) on the project site totaling appx 0.02 acre. Wetland A is a closed depression surrounded by uplands. The wetland was identified using the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual, which requires a dominance of hydrophytic vegetation, wetland hydrology indicators, and

hydric soils, under normal conditions. The nearest water of the United States is Stewarts Creek located approximately 475 east of Wetland A. The nearest Traditional Navigable Water is the West Fork San Jacinto River located approximately 5.3 miles south of Wetland A. According to the FEMA floodplain map, the subject wetland is located outside the 100-year floodplain of any water of the United States. As such it is located outside the anticipated high flow of any water of the United States. Based on the 30 November 2017 site visit and off site review it has been verified that the wetland does not have a confined hydrological surface connection to any water of the United States, nor is it "inseparably bound" to any waters of the United States under normal hydrologic conditions.

-Based on off-site data and on-site data collected during the site visit conducted 30 November 2017, there are no known hydrological connections between Wetland A and Stewarts Creek or any other water of the United States.

-There are no confined surface hydrologic connections between Wetland A and any water of the United States.

-Wetland A is isolated and is not a water of the United States, as defined in 33 CFR 328.3(a). It is not currently used, was not used in the past, nor is it susceptible to use for interstate or foreign commerce. The destruction of the subject wetland would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce.

-Wetland A is not subject to the ebb and flow of the daily tide.

-Wetland A does not cross interstate or tribal boundaries.

-Wetland A is not an impoundment of a water of the United States.

-Wetland is not part of a surface tributary system of any of the above.

-Wetland A is not part of the territorial seas.

-Wetland A is not adjacent (bordering, contiguous, or neighboring) as defined by 33CFR 328.3(c) to any waters of the U.S.

-Wetland A has been determined not to be "ecologically adjacent," as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require the subject wetland and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements.

-Wetland A is an isolated wetland as defined in 33 CFR 330.2(e): those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States, and are not adjacent to such tributary waterbodies. It is located outside of the 100-year floodplain of any water of the United States and does not have a confined hydrological surface connection to any water of the United States.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** There is one isolated wetland (Wetland A) on the project site totaling appx 0.02 acre. Wetland A is a closed depression surrounded by uplands. The wetland was identified using the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual, which requires a dominance of hydrophytic vegetation, wetland



hydrology indicators, and hydric soils, under normal conditions. The nearest water of the United States is Stewarts Creek located approximately 475 feet east of Wetland A. The nearest Traditional Navigable Water is the West Fork San Jacinto River located approximately 5.3 miles south of Wetland A. According to the FEMA floodplain map, the subject wetland is located outside the 100-year floodplain of any water of the United States. As such it is located outside the anticipated high flow of any water of the United States. Based on the 30 November 2017 site visit and off-site review it has been verified that the wetland does not have a confined hydrological surface connection to any water of the United States, nor is it "inseparably bound" to any waters of the United States under normal hydrologic conditions.

-Based on off-site data and on-site data collected during the site visit conducted 30 November 2017, there are no known hydrological connections between Wetland A and Stewarts Creek or any other water of the United States.

-There are no confined surface hydrologic connections between Wetland A and any water of the United States.

-Wetland A is isolated and is not a water of the United States, as defined in 33 CFR 328.3(a). It is not currently used, was not used in the past, nor is it susceptible to use for interstate or foreign commerce. The destruction of the subject wetland would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce.

-Wetland A is not subject to the ebb and flow of the daily tide.

-Wetland A does not cross interstate or tribal boundaries.

-Wetland A is not an impoundment of a water of the United States.

-Wetland is not part of a surface tributary system of any of the above.

-Wetland A is not part of the territorial seas.

-Wetland A is not adjacent (bordering, contiguous, or neighboring) as defined by 33CFR 328.3(c) to any waters of the U.S.

-Wetland A has been determined not to be "ecologically adjacent," as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require the subject wetland and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements.

-Wetland A is an isolated wetland as defined in 33 CFR 330.2(e): those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States, and are not adjacent to such tributary waterbodies. It is located outside of the 100-year floodplain of any water of the United States and does not have a confined hydrological surface connection to any water of the United States.

-The wetland has no known nexus to interstate commerce. We determined the wetland is not a water of the United States and is not subject to Section 404 of the Clean Water Act.

In conclusion, it is SWG's draft determination that this wetland totaling appx 0.02 acre is "isolated" and lacks a nexus to interstate commerce. As such, the wetland is not a water of the United States subject to Section 404 of the Clean Water Act.
