The review area is not subject to the ebb and flow of the daily tide.

The review area is not currently used, has not been used in the past, nor has it been susceptible to use for interstate or foreign commerce.

The review area does not cross interstate or tribal boundaries.

The review area is located outside of the 100-year floodplain of any water of the United States and does not have a confined hydrological surface connection to any water of the United States.

There are no stream features observed by the agent in the field such as an ordinary high water mark or bed and bank features within the review area. There are no indications that this area has flow year-round or continuous flow at least "seasonally."

The nearest year-round flowing stream is 1.45 miles southwest.

This area would carry overland sheet flow during a rain event and not have flow that is confined to a channel.

The gradient of the review area is less than 0.05%, resulting in this area being very flat.

Outside of the review area further downstream towards Falcon reservoir, OHWM features and bed and bank features were observed. The review area is likely an headwater where overland sheet flow begins to accumulate, but not enough to exhibit features of a stream.

Falcon Reservoir is at a lower elevation than the review area.

There is an existing dirt road that transects part of the review area that has created a man-made disturbance to this portion of the review area.

As such, the review area is not a water of the United States subject to Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The review area is not subject to the ebb and flow of the daily tide. The review area is not currently used, has not been used in the past, nor has it been susceptible to use for interstate or foreign commerce. The review area does not cross interstate or tribal boundaries. The review area is not located within the FEMA 100-year floodplain, the floodplain is located approximately 3,000 feet southwest and downstream. Field observations from the consultatns and pictures of the site determine that no stream features exhibiting an ordinary high water mark or bed and bank features exist within the review area. The nearest year-round flowing stream is 1.45 miles away. This area would carry overland sheet flow during a rain event and not have flow that is confined to a channel. Also, the gradient of the review area is less than 0.05%, resulting in this area to be very flat. Outside of the review area further downstream towards Falcon reservoir, OHWM and bed and bank features were observed. Falcon Reservoir is at a lower elevation than the review area. The review area is likely a headwater area where overland sheet flow begins to accumulate, but not enough to exhibit features of a stream. Furthermore, there is an existing dirt road that transects part of the review area that has created a man-made disturbance to this portion of the review area. As such, the review area is not a waters of the United States subject to Section 404 of the Clean Water Act.
