C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This AJD is for one aquatic resource, specifically "Crossing 15, Wetland 14", located within the review area. However, this AJD does not provide a determination for the entire review area as the Corps could not verify the wetland delineation report. It was determined that the wetland delineation report does not provide sufficient data to substantiate the presence or absence of all potential aquatic resources located within the review. As such, the Corps does not concur with the wetland

delineation report. The Corps anticipates a revised wetland delineation report will be submitted for verification at a later date. This AJD will be revised once a revised wetland delineation report depicting all aquatic resources has been submitted and verified.
