Delineation Manual which under normal circumstances exhibits a dominance of hydrophytic vegetation, wetland hydrology indicators, and hydric soils. The nearest known water of the United States is Robinson Bayou, a relatively permanent water.

Based on the site visit conducted 21 March 2018, there is no known hydrological connection between the wetland and Robinson Bayou. A review of the FEMA FIRM map show the wetland located outside of the FEMA 100-year floodplain of Robinson Bayou. Wetland 1 is approximately 0.9 mile east of Robinson Bayou. There are no confined hydrologic connections between the wetland and any water of the United States determined by on-site and off-site data. The wetland is not adjacent to any waters of the United States as defined by 33 CFR 328.3(c).

Wetland 1 is isolated and is not a water of the United States, as defined in 33 CFR 328.3(a). Isolated waters are defined in 33 CFR 330.2(e) as those non-tidal waters that are: (1) Not part of a surface tributary system to interstate or navigable waters of the United States; and (2) Not adjacent to such tributary waterbodies.

- **The wetland is not currently used, was not used in the past, nor is susceptible to use in interstate or foreign commerce.**
 - **The wetland is not subject to the ebb and flow of the daily tide, nor is it part of a territorial sea.**

The wetland has no known nexus to interstate commerce. Therefore, we determined the wetland is not a water of the United States and is not subject to Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Isolated waters are defined in 33 CFR 330.2(e) as those non-tidal waters that are: (1) Not part of a surface tributary system to interstate or navigable waters of the United States; and (2) Not adjacent to such tributary waterbodies.

- The wetland is not currently used, was not used in the past, nor is susceptible to use in interstate or foreign commerce.
- The wetland is not subject to the ebb and flow of the daily tide, nor is it part of a territorial sea.
- Wetland 1 does not cross interstate or tribal boundaries.
- The wetland is "isolated" and does not currently nor was in the past associated with affecting (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or, (iii) current use or potential use for industrial purposes by industries in interstate commerce.
- The wetland is not an impoundment of water of the United States.
- The wetland is not, nor was it ever, part of a surface tributary system.
- The wetland is not "adjacent" (as defined by federal regulations) to any other water of the US.
- The wetland was determined not to be "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this geographic region that require both the subject wetland and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements.

In conclusion, it is SWG draft determination that the wetland on the tract, totaling approximately 0.006 acre, is isolated (as per federal regulation) and does not possess any known nexus to interstate commerce. As such, the wetland is not subject to federal regulation under Section 404 of the Clean Water Act.
