C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: An approximately 617-linear-foot roadside drainage ditch was identified within the review area, parallel to the eastern review area boundary and Rowe St. A second, approximately 275-linear-foot roadside drainage ditch was identified within the review area, parallel to the western review area boundary along Hickory Ave. These features were determined to be excavated in and draining only uplands, and do not hold a relatively permanent flow of water.

In general, the Corps does not consider non-tidal drainage and irrigation ditches excavated on dry land to be waters of the U.S. However, the Corps does reserve the right on a case-by-case basis to determine that a particular waterbody is a water of the U.S. In addition, the Corps' Jurisdictional Determination Form Instructional Guidebook states that, "Ditches (including roadside ditches) excavated wholly in and draining only uplands and that do not carry a relatively permanent flow of water, generally are not jurisdicitonal under the Clean Water Act. Even when not themselves waters of the U.S., ditches may still contribute to a surface hydrologic connection between an adjacent wetland and a TNW." As such, the roadside drainage ditches identified within the review area are not considered jurisdictional under the CWA.

The applicant identified a swale in the same general area as the features noted on both the 2016 topographic map and the NWI map. The swale exhibits no OHWM or indicators of wetland vegetation or hydrology. The Corps' Jurisdictional Determination Form Instructional Guidebook states that, "Swales are generally not waters of the U.S. because they are not tributaries or they do not have a significant nexus to TNWs. Even when not themselves waters of the United States, swales may still contribute to a surface hydrologic connection between an adjacent wetland and a TNW." As such, the swale identified within the review area is not considered jurisdictional under the CWA.

Based on a review of data listed in Section III above and applicable Corps guidance (as listed below), it has been determined that there are no aquatic resources or potential aquatic resources in the 5.3-acre review area that would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides, and there are no features that exhibit lateral limits of jurisdiction (e.g. OHWM). The 5.3-acre review area consists entirely of dry land.
