C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The A-AD-01 review area consists primarily of agricultural fields on either side of County Road (CR) 26. Google Earth aerial imagery depicts a clearing north of CR 26 that was created for oil/natural gas operations. SWCA confirmed that an approximately 20-foot-wide drainage swale occurs within the review area, north of CR 26. Based on the supporting data, as detailed above, the Corps has determined that this drainage swale was excavated in and drains only uplands, does not carry a relatively permanent flow of waters, and does not exhibit lateral limits of jurisdiction (e.g. ordinary high water mark). Therefore, the Corps has determined that this geographic feature is not a water of the U.S.

The Corps has determined that there are no aquatic resources or potential aquatic resources within this approximately 8.6 acre review area that would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides. There are no features that exhibit lateral limits of jurisdiction (e.g. OHWM) or wetland characteristics within the review area ; therefore, the Corps has determined that the review area consists entirely of dry land.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The A-AD-03 review area consists of agricultural fields west of County Road 19. SWCA identified a drainage swale, lacking bed and bank characteristics, within the review area. According to the topographic map, a natural tributary of Aquilla Creek flowed through the review area. The 1950 Google Earth aerial image indicates that the review area was forested, at that time, and a stream feature can be discerned traversing the area. However, local agricultural practices led to the feature being straightened and reconfigured as a drainage swale. The NWI map indicates that the drainage swale is a wetland that is temporary flooded on occasion. During the Corps' site visit, vegetation observed within the swale, both within the review area and outside, consisted entirely of dryland herbaceous forbs and grasses. Therefore, the Corps determined that the NWI feature designation is not representative of the existing habitat within the review area. Although the review area occurs outside the 100-year floodplain, the swale is likely to collect rainfall runoff from the surrounding landscape. Current Google Earth aerial imagery, the photograph provided by SWCA, and observations made during the Corps' site visit indicate that the feature does not exhibit defined bed and bank characteristics. Due to the lack of an ordinary high water mark or bed and bank characteristics within the swale feature, it appears that flow through this feature only occurs after heavy rainfall events.

Based on the supporting data, as detailed above, the Corps has determined that the feature observed within the review area is a drainage swale that does not exhibit bed and bank characteristics, does not carry a relatively permanent flow of waters, and does not exhibit lateral limits of jurisdiction (e.g. ordinary high water mark). Therefore, the Corps has determined that this geographic feature is not a water of the U.S. However, it should be noted that even when not jurisdictional waters, swales may still contribute to a surface hydrologic connection between an adjacent wetland and a traditional navigable water.

The Corps has determined that there are no aquatic resources or potential aquatic resources within this approximately 10.4-acre review area that would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides. The Corps has determined that the review area contains no features that exhibit lateral limits of jurisdiction (e.g. OHWM) or wetland characteristics within the review area.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The A-AD-08 review area consists of agricultural fields located northeast, southeast, and southwest of the County Road (CR) 24 and CR 21 intersection. SWCA identified a 25- to 30-foot-wide drainage swale, lacking bed and bank characteristics, within the review area. According to the topographic map, the drainage swale identified by SWCA is mapped as Aquilla Creek. The 1950 Google Earth historic aerial image indicates that the review area consisted primarily of agricultural land, but shrub/scrub and forest habitat were present along a stream feature identified traversing the review area. However, the 1995 imagery indicates that local agricultural practices led to the feature being straightened and reconfigured as a drainage swale, with no riparian corridor. The NWI map indicates that the drainage swale is a wetland. During the Corps' site visit, vegetation observed within the swale, both within the review area and outside, consisted entirely of dryland herbaceous forbs and grasses. Therefore, the Corps determined that the NWI feature designation is not representative of the existing habitat within the review area. Although the review area occurs outside the 100-year floodplain, the swale is likely to collect rainfall runoff from the surrounding landscape. The photograph provided by SWCA and observations made during the Corps' site visit indicate that the feature does not exhibit defined bed and bank characteristics, or other physical characteristics that typically indicate an ordinary high water mark (i.e. natural line impressed on the bank, shelving, destruction of terrestrial vegetation, wracking, vegetation matted down or absent, scour, water staining, or a change in the plant community). Due to the lack of an ordinary high water mark (OHWM) within the swale feature, it appears that flow through this feature is ephemeral, only occurring after heavy rainfall events.

Based on the supporting data, as detailed above, the Corps has determined that the feature observed within the review area is a drainage swale that does not exhibit bed and bank characteristics, does not carry a relatively permanent flow of water, and does not exhibit lateral limits of jurisdiction (e.g. OHWM). Therefore, the Corps has determined that this geographic feature is not a water of the U.S. However, it should be noted that even when not jurisdictional waters, swales may still contribute to a surface hydrologic connection between an adjacent wetland and a traditional navigable water.

The Corps has determined that there are no aquatic resources or potential aquatic resources within this approximately 43.4-acre review area that would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides. The Corps has determined that the review area contains no features that exhibit lateral limits of jurisdiction (e.g. OHWM) or wetland characteristics within the review area.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The A-AD-09 review area consists primarily of agricultural fields north of the County Road (CR) 530 and 533 intersection. SWCA's submitted documentation identified a system of man-made drainage ditches that lack an ordinary high water mark within the review area. Although the topographic map and NWI map both indicate that a stream feature occurs within the review area, Google Earth aerial imagery and the photograph provided by SWCA indicate that the feature does not exhibit defined bed and bank characteristics. Historic Google Earth aerial imagery from 1950 indicates that the review area consisted primarily of scrub/shrub and/or forested land and a small portion of agricultural field. Since then the scrub/shrub and forested land was cleared and converted entirely into agricultural use. Upon doing so, drainage ditches were excavated to prevent long-term flooding of the agricultural fields. Based on the supporting data, as detailed above, the Corps has determined that the system of drainage ditches identified within the review area were excavated in and drains only uplands, does not carry a relatively permanent flow of waters, and does not exhibit lateral limits of jurisdiction (e.g. ordinary high water mark). Therefore, the Corps has determined that this geographic feature is not a water of the U.S.

The Corps has determined that there are no aquatic resources or potential aquatic resources within this approximately 48.9-acre review area that would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides. There are no features that exhibit lateral limits of jurisdiction (e.g. OHWM) or wetland characteristics within the review area; therefore, the Corps has determined that the review area consists entirely of dry land.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The A-AD-12 review area consists of agricultural fields located west of the County Road (CR) 19 and CR 18 intersection. SWCA identified an approximately 50-foot-wide drainage swale, lacking bed and bank characteristics, within the review area. According to the topographic map, the drainage swale identified by SWCA is mapped as a tributary of Aquilla Creek. The 1950 Google Earth historic aerial image indicates that the review area consisted primarily of agricultural land, but shrub/scrub and forest habitat were present along a portion of the tributary and its confluence with Aquilla creek. However, the 1995 imagery indicates that local agricultural practices led to both features being straightened and reconfigured as a drainage swales, with no riparian corridor. The NWI map indicates that the drainage swale is a wetland. During the Corps' site visit, vegetation observed within the swale consisted entirely of dryland herbaceous forbs and grasses. Therefore, the Corps determined that the NWI feature designation is not representative of the existing habitat within the review area. Although the review area occurs outside the 100-year floodplain, the swale is likely to collect rainfall runoff from the surrounding landscape. The photograph provided by SWCA and observations made during the Corps' site visit indicate that the feature does not exhibit defined bed and bank characteristics, or other physical characteristics that typically indicate an ordinary high water mark (OHWM) (i.e. natural line impressed on the bank, shelving, destruction of terrestrial vegetation, wracking, vegetation matted down or absent, scour, water staining, or a change in the plant community). Water flow through this feature is ephemeral, only occurring after heavy rainfall events, and does not occur frequently enough or at a rate of flow significant enough to create physical characteristics of an OHWM.

Based on the supporting data, as detailed above, the Corps has determined that the feature observed within the review area is a drainage swale that does not exhibit bed and bank characteristics, does not carry a relatively permanent flow of water, and does not exhibit lateral limits of jurisdiction (e.g. OHWM). Therefore, the Corps has determined that this geographic feature is not a water of the U.S. However, it should be noted that even when not jurisdictional waters, swales may still contribute to a surface hydrologic connection between an adjacent wetland and a traditional navigable water.

The Corps has determined that there are no aquatic resources or potential aquatic resources within this approximately 24.9-acre review area that would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides. The Corps has determined that the review area contains no features that exhibit lateral limits of jurisdiction (e.g. OHWM) or wetland characteristics within the review area.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The A-AD-15 review area consists of agricultural fields and cattle grazing pasture south of the County Road (CR) 526. SWCA's submitted documentation identified a man-made drainage swale that lacks an ordinary high water mark within the review area. The topographic map indicates that a stream feature begins within the eastern portion of the review area boundary. Historic Google Earth aerial imagery from 1950 indicates that the entire review area consisted of scrub/shrub and/or forested land. Since then, the land was cleared and converted entirely into agricultural use. The imagery from 1950 does not suggest the presence of a stream feature within the review area, at that time. After the land was cleared for agricultural use, the existing drainage ditch was excavated to prevent long-term flooding of the agricultural fields. The NWI map indicates that a stream feature occurs within the review area, west of the private farm road. The NWI map also indicated that a palustrine emergent wetland feature occurs within the review area, east of the private farm road. During the Corps' site visit, vegetation within the swale, both within the review area and outside, consisted entirely of dryland herbaceous forbs and grasses. A few scattered hackberry trees were observed on the east side of the farm road. Therefore, the Corps determined that the features indicated on the NWI map are not representative of the existing habitat within the review area. Google Earth aerial imagery and the photograph provided by SWCA indicate that the feature does not exhibit defined bed and bank characteristics. Based on the supporting data, as detailed above, the Corps has determined that the drainage swale identified within the review area was excavated in and drains only uplands, does not carry a relatively permanent flow of waters, and does not exhibit lateral limits of jurisdiction (e.g. ordinary high water mark). Therefore, the Corps has determined that this geographic feature is not a water of the U.S.

The Corps has determined that there are no aquatic resources or potential aquatic resources within this approximately 8.3-acre review area that would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides. There are no features that exhibit lateral limits of jurisdiction (e.g. OHWM) or wetland characteristics within the review area; therefore, the Corps has determined that the review area consists entirely of dry land.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The B-AD-02 review area consists of agricultural fields and pasture lands east of Interstate Highway (IH) 37. SWCA confirmed that an approximately 60-foot-wide drainage swale, lacking bed and bank characteristics, occurs within the review area. According to the 1979 topographic map, a tributary of Bayou Creek flowed through the review area at one time. A comparison of the 2011 and 1950 Google Earth aerial images indicate that a tributary flowed freely through the review area between 1950 and 1979; however, local agricultural practices lead to the feature being straightened and reconfigured as a drainage swale. The NWI map indicates that the drainage swale is a palustrine forested wetland that is temporary flooded on occasion. During the Corps' site visit, vegetation observed within the swale, both within the review area and outside, consisted entirely of dryland herbaceous forbs and grasses. No trees or shrubs were observed within the review area, or within the immediate vicinity. Therefore, the Corps determined that the NWI feature designation of PFO1A is not representative of the existing habitat within the review area. Since the review area occurs within the 100-year floodplain, the swale is likely to collect rainfall runoff from the surrounding landscape; however, due to the lack of an ordinary high water mark or bed and bank characteristics within the swale feature, flow through this feature is intermittent and likely only occurs after heavy rainfall events.

Based on the supporting data, as detailed above, the Corps has determined that the drainage swale within the review area does not exhibit bed and bank characteristics, does not carry a relatively permanent flow of waters, and does not exhibit lateral limits of jurisdiction (e.g. ordinary high water mark). Therefore, the Corps has determined that this geographic feature is not a water of the U.S.

The Corps has determined that there are no aquatic resources or potential aquatic resources within this approximately 0.7 acre review area that would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides. The Corps has determined that the review area contains no features that exhibit lateral limits of jurisdiction (e.g. OHWM) or wetland characteristics within the review area.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The B-AD-06 review area consists primarily of agricultural fields. Google Earth aerial imagery depicts an unnamed, unpaved road that crosses the review area. SWCA confirmed that, on either side of the unpaved road, a depression swale that lacks a defined bed and bank occurs within the review area. Google Earth historical aerials indicate that the review area consisted of agricultural land and scrub/shrub land, but the entire review area was converted to agricultural use by 1961. Based on the supporting data, as detailed above, the Corps has determined that this drainage swale was excavated in and drains only uplands, does not carry a relatively permanent flow of waters, and does not exhibit lateral limits of jurisdiction (e.g. ordinary high water mark). Therefore, the Corps has determined that this geographic feature is not a water of the U.S.

The Corps has determined that there are no aquatic resources or potential aquatic resources within this approximately 3.1 acre review area that would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides. There are no features that exhibit lateral limits of jurisdiction (e.g. OHWM) or wetland characteristics within the review area; therefore, the Corps has determined that the review area consists entirely of dry land.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The B-AD-08 review area consists primarily of agricultural fields north of Farm to Market (FM) 796. SWCA's submitted documentation identified a swale that lacks an ordinary high water mark and crosses through the review area. Although the topographic map and NWI map both indicate that a stream feature occurs within the review area, Google Earth aerial imagery, Google Earth street view photographs, and the photograph provided by SWCA indicate that the feature does not exhibit defined bed and bank characteristics. Based on the supporting data, as detailed above, the Corps has determined that this drainage swale was excavated in and drains only uplands, does not carry a relatively permanent flow of waters, and does not exhibit lateral limits of jurisdiction (e.g. ordinary high water mark). Therefore, the Corps has determined that this geographic feature is not a water of the U.S.

The Corps has determined that there are no aquatic resources or potential aquatic resources within this approximately 0.8-acre review area that would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides. There are no features that exhibit lateral limits of jurisdiction (e.g. OHWM) or wetland characteristics within the review area; therefore, the Corps has determined that the review area consists entirely of dry land.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The B-AD-15 review area consists primarily of agricultural fields northwest of the Farm to Market (FM) 796 and County Road (CR) 533 intersection. SWCA's submitted documentation identified a drainage swale that lacks an ordinary high water mark within the review area. The topographic map indicates that Papalote Creek occurs within the review area boundary. Historic Google Earth aerial imagery from 1950 indicates evidence of a defined creekbed within forested land occurred within the review area, at the time. Historic Google Earth aerial imagery from 1995 indicates that the land was cleared and converted into agricultural use, and that Papalote Creek was reformed into a drainage swale, with no obvious sign of a defined creekbed. The NWI map also indicates that a stream feature occurs within the review area, in the same location as the feature mapped on the topographic map. During the Corps' site visit, most of the vegetation within the swale had been recently burned, both within the review area and outside, but the remaining vegetation was identified as dryland herbaceous grasses. A few scattered hackberry trees were observed adjacent to the swale feature inside the southern boundary of the review area. Therefore, the Corps determined that the feature indicated on the NWI map is not representative of the existing habitat within the review area. Since the review area occurs within the 100-year floodplain, the swale is likely to collect rainfall runoff from the surrounding landscape, which would flow south outside of the review area boundary into Papalote Creek (east of CR 533) where a defined bed and bank were observed by the Corps during the site visit. Due to the lack of an ordinary high water mark or bed and bank characteristics within the swale feature, it appears that flow through this feature is intermittent and likely only occurs after heavy rainfall events. Google Earth aerial imagery, the photograph provided by SWCA, and observations made during the Corps' site visit indicate that the feature does not exhibit defined bed and bank characteristics.

Based on the supporting data, as detailed above, the Corps has determined that, although Papalote Creek historically flowed through the review area, the existing feature no longer carries a relatively permanent flow of waters and does not exhibit lateral limits of jurisdiction (e.g. ordinary high water mark). Therefore, the Corps has determined that this geographic feature is not a water of the U.S. However, it should be noted that even when not jurisdictional waters, swales may still contribute to a surface hydrologic connection between an adjacent wetland and a traditional navigable water.

The Corps has determined that there are no aquatic resources or potential aquatic resources within this approximately 1.8-acre review area that would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides. There are no features that exhibit lateral limits of jurisdiction (e.g. OHWM) or wetland characteristics within the review area; therefore, the Corps has determined that the review area consists entirely of dry land.
