#### C. SIGNIFICANT NEXUS DETERMINATION

Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The geographic limits (boundaries) of jurisdiction within the review area were not established by this AJD because a wetland delineation, in accordance with the Corps' 1987 Delineation Manual and Atlantic and Gulf Coastal Plain Region Supplement (v2), was not submitted or requested. The applicant requested a determination based on the information provided. Based on the information provided by the applicant's agent, a site visit conducted on 8 February 2018 by the Corps, and additional information collected during the desktop investigation of the review area, we have determined that approximately 6 acres of jurisdictional wetlands occur within the review area. As discussed in Section III.A.1 and 2 previously, the two aquatic resources identified within the review area, as listed below, are adjacent to Redfish Bay via a continuous surface connection. As such, AR-1 and AR-2 are subject to Section 404 of the Clean Water Act.
