Summarize rationale supporting conclusion that wetland is “adjacent”: The unnamed perennial stream is abutting Brazos River and the Brazos River ordinary high water extends into the perennial stream 140 linear feet within the project boundary; therefore, the perennial stream is jurisdictional due to a TNW ordinary high water extension and because it is considered a relative permanent water. Therefore, approximately 140-linear feet of the confluence of the stream is subject to Section 10 of the Rivers and Harbors Act and the entire stream is subject to Section 404 of the Clean Water Act.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
