### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The East Fork San Jacinto River had water flowing during the date of the site visit, and water is present within all aerial photos viewed. The USGS stream gage 08070000 East Fork San Jacinto River near Cleveland, TX, shows water discharge year round. The National Hydrologic Dataset characterizes the East Fork San Jacinto River as a perennial waterbody, and is therefore a relatively permanent water. Unnamed Tributary 2 extends the ordinary high water mark of the East Fork San Jacinto River and is therefore also a RPW. The abutting wetlands share a topographic surface drainage connection with the East Fork San Jacinto River.
