### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The site is surrounded by agricultural crop fields. The Project will require work within an irrigation canal. The irrigation canal appears to have been manmade, constructed in uplands based on topography and straight line course of canal, and is currently maintained with levees. These canals are not part of a surface tributary system, and do not expand the OHWM of any water of the US. Water from the Rio Grande is pumped into the ditches for irrigation needs. These canals are managed according to water demand (withdrawals) or water surpluses (releases); however, man-made retention structures hold water in the ditch for extended periods of time and can create palustrine conditions. Aerial photography and topographical maps do not show any indication of current or historical hydrology that is/was natural. These canals at various locations are not WOUS and are not subject to Section 404 of the CWA, or Section 10 of the Rivers and Harbors Act of 1899. Per 33 CFR 328.3(b)(4)(i), which states that artificially irrigated areas that would revert to dry land should application of water to that area cease are not considered waters of the US.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The Pilot Channel of the North Floodway is federally maintained as a component of the Lower Rio Grande Valley drainage system, which diverts floodwaters from the Rio Grande to the Laguna Madre. A riparian zone is contiguous and directly abutting the Pilot Channel and is considered jurisdictional under Section 404 of the Clean Water Act. There is surface water that continuously flows throughout the year east along the North Floodway Pilot Channel into an estuary of the Laguna Madre, which is a TNW housing the GIWW, a federal channel. A direct hydrological connection to the Laguna Madre is apparent in historical aerial photography and historical topographical maps.
