#### **SECTION III: CWA ANALYSIS**

#### A. TNWs AND WETLANDS ADJACENT TO TNWs

The agencies will assert jurisdiction over TNWs and wetlands adjacent to TNWs. #### 1. TNW

Identify TNW: Copano Bay

Summarize rationale supporting determination: Copano Bay is subject to the ebb and flow of the tide as demonstrated by clear indicators of mean and annual high tide lines. Per 33 CFR 328.4(b)(1) tidal Section 10 waters are also jurisdictional under Section 404 of the Clean Water Act. All of the wetlands directly adjacent to Copano Bay are within the mean high water line and annual high tide line and receive influence from the ebb and flow of the tide via Copano Bay.

#### 2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is "adjacent": The adjacent wetlands are directly abutting Copano Bay and demonstrated clear indicators that they are subject to the ebb and flow of the tide. In addition, the wetlands are within the 1% annual flood risk zone (100-year floodplain) of Copano Bay. Under normal circumstances the wetlands exhibit a predominance of hydrophytic vegetation, wetland hydrology, and hydric soils, as defined in the 1987 Corps of Engineers Wetland Delineation Manual and the Atlantic and Gulf Coastal Plain Regional Supplement (Version 2.0). Therefore, per 33 CFR 328.3(c) the wetland is adjacent to Copano Bay and subject to jurisdiction under Section 404 of the Clean Water Act and Section 10 of the Rivers and Harbors Act.

#### B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. If the water body<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the water body has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. The determination whether a significant nexus exists is determined in Section III.C below.

#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B.** ADDITIONAL COMMENTS TO SUPPORT JD: Copano Bay is listed on the Galveston District's Navigable Waters List and is subject to the ebb and flow of the tide; therefore, it is subject to Section 10. Per 33 CFR 328.4(b)(1), water subject to the annual high tide is also subject to Section 404 of the Clean Water Act. The estuarine wetland and unvegetated flat have a direct hydrologic connection to Copano Bay and are subject to Section 404 up to the annual high tide line (AHTL). There is not a portion of the estuarine wetland or unvegetated flat that occurs outside of the AHTL.
