The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Review of aerial photographs since 1995 demonstrate that the Arroyo Colorado is a relatively permanent water that flows year-round. The National Hydrologic Database reports this reach of the Arroyo Colorado maintaining a mean annual flow rate of 35.05 cubic feet per second. The Arroyo Colorado flows approximately 3 miles from the review area to the Port

of Harlingen Turning Basin, which is considered the headwaters of the federally maintained, navigable portion of the waterbody. The Arroyo Colorado is listed on Galveston District's Navigable Waters list (Section 10 list) from its mouth on the Laguna Madre to the Port of Harlingen Turning Basin. The Arroyo Colorado has been, is currently used, and has potential to be used in the forseeable future for interstate commerce. All Section 10 waters are Traditionally Navigable Waters and are subject to jurisdiction under Section 404 of the Clean Water Act.
