- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **There were seven wetlands identified within the review area that were determined to be isolated, and as such not jurisdictional. Isolated waters are defined in Federal Regulations 33 CFR 330.2(e) as those non-tidal waters that are: (1) Not part of a surface tributary system to interstate or navigable water of the United States; and (2) Not adjacent to such tributary water bodies. Based on supporting data (detailed in Section IV(a) of this document) and observations made during the site visit, there are no confined hydrologic connections between the identified wetlands and Aransas Bay or any other water of the United States. As stated in 33 CFR 328.3(c), the term adjacent refers to a wetland that is bordering, contiguous, or neighboring waters of the United states (defined in 33 CFR 328.3(a)1-6). The seven wetlands identified within the review area do not border, are not contiguous with, nor do they occur near any potential or known water of the United States. Furthermore, these wetlands are not considered "ecologically adjacent" since the identified aquatic resources are not known to provide life cycle dependent aquatic habitat for species located in a water identified in 33 CFR 328.3(a)1-3. These aquatic resources do not cross interstate or tribal boundaries, and there is no known nexus between these resources and interstate commerce. Therefore, the seven wetlands identified within the review area are isolated. As such, these resources are not subject to regulation under Section 404 of the Clean Water Act.**

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** There were seven wetlands identified within the review area that were determined to be isolated, and as such not jurisdictional. Isolated waters are defined in Federal Regulations 33 CFR 330.2(e) as those non-tidal waters that are: (1) Not part of a surface tributary system to interstate or navigable water of the United States; and (2) Not adjacent to such tributary water bodies. Based on supporting data (detailed in Section IV(a) of this document) and observations made during the site visit, there are no confined hydrologic connections between the identified wetlands and Aransas Bay or any other water of the United States. As stated in 33 CFR 328.3(c), the term adjacent refers to a wetland that is bordering, contiguous, or neighboring waters of the United states (defined in 33 CFR 328.3(a)1-6). The seven wetlands identified within the review area do not border, are not contiguous with, nor do they occur near any potential or known water of the United States. Furthermore, these wetlands are not considered "ecologically adjacent" since the identified aquatic resources are not known to provide life cycle dependent aquatic habitat for species located in a water identified in 33 CFR 328.3(a)1 3. These aquatic resources do not cross interstate or tribal boundaries, and there is no known nexus between these resources and interstate commerce. Therefore, the seven wetlands identified within the review area are isolated. As such, these resources are not subject to regulation under Section 404 of the Clean Water Act.
