### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The applicant's submitted delineation contained a data point from the only identified wetland feature within the review area (Wetland B). The wetland delineation data form documented the presence of all three wetland criteria within the approximately 0.1 acre feature. Vegetation was documented as hydrophytic, soils were documented as meeting the criteria of the depleted matrix hydric soil indicator, and one primary wetland hydrology indicator was recorded (oxidized rhizospheres on living roots), as well as one secondary wetland hydrology indicator (FAC-neutral Test). The Corps' site visit confirmed the accuracy of the submitted data sheet, and that the feature does meet all three wetland criteria, in accordance with the 1987 Corps Delineation Manual and Great Plains Regional Supplement. However, it was also noted that the feature receives a supplemental water supply from a nearby groundwater well and windmill pump. Although the topographic map indicates that this wetland feature was formed (either naturally or by human modification) within the flow path of an intermittent tributary, the Corps' site visit confirmed that the wetland had no discrete geographic feature (i.e. swale, erosional features, ditch, or tributary) directing flow into or out of the wetland. As already stated in Section II.B.2., the "stream feature" indicated on the topographic map to the north of this wetland was determined to be a swale with no bed and bank or OHWM, which became completely imperceptible as it approached the 100-year floodplain at the northern boundary of the review area. The Corps' site visit concluded that the wetland does not have a discernable or discrete continuous surface (e.g. swale, erosional feature, ditch, etc.) or shallow sub-surface connection to waters of the U.S. Additionally, the nearest jurisdictional water, Nueces River, is approximately 0.4 mile from the wetland. Since this wetland does not meet any adjacency criteria, this wetland is a non-jurisdictional, isolated wetland.
