This feature has been excavated a couple of feet below normal surrounding upland surface elevations and based on historical review of the USGS topos, sol surveys and aerials it is not a re-routed tributary. This ditch join the intermittent waters of South Maydy Creek passing through U201-09-00 for a short distance,

however, it is located above the ordinary high water mark of South Mayde Creek. In accordance with federal regulations, this upland drainage ditch is not a re-routed tributary, it does not extend the ordinary high water mark of the nearby water of the U.S., South Mayde Creek, and it does not have perennial flow. Therefore, this feature is a upland drainage ditch and would not be considered a water of the U.S. subject to Section 404 of the Clean Water Act. It was noted from the site visit that water is found in small pockets along the ditch and some wetland are also found. The coprs conclusion that this waterbody is an upland drainage ditch and not a water of the U.S. subject to Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The coprs conclusion that this waterbody is an upland drainage ditch and not a water of the U.S. subject to Section 404 of the Clean Water Act.
