**C. SIGNIFICANT NEXUS DETERMINATION**

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The wetlands are adjacent to a RPW (Resaca de los Cuates) being separated from the wetlands by riparian zone to the south and man-made road to the east. These wetlands are within a floodplain and contributes to the retention of flood waters within the watershed and its release into the resaca. In addition, the wetlands are within the 1% annual flood risk zone (100-year floodplain). In addition the onsite visit indicated that the wetlands exhibit a predominance of hydrophytic vegetation, wetland hydrology, and hydric soils, as defined in the 1987 Corps of Engineers Wetland Delineation Manual and the Atlantic and Gulf Coastal Plain Regional Supplement (Version 2.0). Therefore, per 33 CFR 328.3(c) the wetlands are adjacent to an RPW (Resaca de los Cuates) that flows into a TNW (Laguna Madre), and is subject to jurisdiction under Section 404 of the Clean Water Act.
