### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The entire project area is comprised of uplands (15.31 acres). No wetlands or other waters are present within the limits of the project area. The upland areas are dominated by Bahia grass (*Paspalum notatum*), tall golden rod

(*Solidago altissima*), Chinese Tallow (*Triadica sebifera*), yaupon, (*Ilex vomitoria*), Bermudagrass (*Cynodon dactylon*) and St. Augustine Grass (*Stenotaphrum secundatum*) according data sheets provided by the consultant. No hydric soils were determined to exist on the subject property according to data sheets provided by the consultant
