Explain: PEM Wetland (SP-1) is located on the southeast corner near the intersection of Clay Road and Katy Hockley Cut Off Road and is a freshwater wetland depression that has formed over time through existing agricultural work on the project

site. PEM wetland (**SP-1**) exists entirely with the mapped Katy fine sandy loam, 0 to 1 percent slopes, (Kf) soil type which is listed as containing hydric components in the depressions in Harris County. PEM Wetland does not exist within a designated FEMA floodplain. PEM Wetland(**SP-1**) measures approximately 0.001 acre in size within the project limits and is dominated by hydrophytic vegetation including common spikerush and woodrush flatsedge. PEM Wetland (**SP-1**) does not appear to have a hydrological connection to any waters of the U.S..

Based on the topography and aerial imagery, the majority of the site is typical for existing roadways with roadside ditches paralleling the road. The roadside ditches collectively drain into Harris County Flood Control District Unit Number U101-09-00. The wetlands were identified using the 1987 Manual regional supplement: Atlantic and Gulf Coastal Plain Region, which requires that all three wetland criteria be present under normal circumstances for areas to be determined a wetland. The wetland is a depressional area that experiences seasonal hydrology during and after rain events, providing the conditions necessary for wetlands to establish.

The nearest Waters of the U.S. (South Mayde Creek) is located approximately 3 miles east of PEM Wetland. PEM Wetland (**SP-1**) is not located in reasonable close proximity to any Waters of the U.S. As such, under normal conditions in the hydrologic cycle, the wetland would not be anticipated to share surface hydrology with the nearest Waters of the U.S. It is not tidal waters, nor part of any surface water tributary system to interstate water or navigable waters of the U.S. nor is it located "adjacent" (as defined in federal regulations) to any tributary waters; as such the wetland has been determined to be "isolated" as defined in federal regulations (33 CFR 330.2(e)).

"Adjacent" as per Federal regulations 33 CFR 328.3 is defined as "bordering, contiguous or neighboring." Wetlands separated from other Waters of the U.S. by man-made dikes or barriers, natural river berms, beach dunes and the like are 'adjacent wetlands.'" The nearest Waters of the U.S. to the wetland is South Mayde Creek. **The** wetland **does** not border nor is it contiguous (abutting) to South Mayde Creek. The wetland is not neighboring South Mayde Creek as determined by the fact that it is, under normal conditions in the hydrologic cycle, not located in reasonably close proximity to another Water of the U.S. (and is not located in the contiguous or bordering landscape position) that would have shared surface hydrology with another water of the U.S. during expected high flow (e.g. the 100-year floodplain). Nor is there any known demonstrable species ecological interconnection requiring the wetland in question and the nearest waters of the U.S. to spawn and/or fulfill the life cycle requirements. PEM Wetland (**SP-1**) is physically separated from other waters of the U.S. by geographic factors that **does** not allow the exchange of waters, via a confined surface hydrology connection during normal conditions and are not inseparably bound with South Mayde Creek.

"Isolated" waters as defined in 33 CDR 330.2(e) is: "those non-tidal waters of the U.S. that are: (1) not part of a surface tributary system to interstate or navigable waters of the U.S.; and (2) not adjacent to such tributary waterbodies." The wetland has been identified as a wetland (aquatic resource) that have been determined to be isolated.

"Waters of the U.S." are defined in 33 CFR 328.3(a) 1 thru 7 which is addressed in the following. Due to the fact that the wetland: (1) is not currently used, or was used in the past, nor susceptible to use for interstate or foreign commerce nor subject to the ebb and flow of the daily tide; (2) do not cross interstate or tribal boundaries; (3) the destruction of this wetland is not expected to affect (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or (iii) current use or potential use for industrial purposes by industries in interstate commerce; (4) are not impoundments of waters of the U.S.; (5) are not part of a surface tributary system of (a) (1) through (4); (6) are not part of the territorial seas; and (7) are not adjacent to waters of the U.S. identified in (a)(1) through (6) and this area (PEM Wetland (**SP-1**)) is not a water of the U.S.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: PEM Wetland (SP-1) is located on the southeast corner near the intersection of Clay Road and Katy Hockley Cut Off Road and is a freshwater wetland depression that has formed over time through existing agricultural work on the project site. PEM wetland (SP-1) exists entirely with the mapped Katy fine sandy loam, 0 to 1 percent slopes, (Kf) soil type which is listed as containing hydric components in the depressions in Harris County. PEM Wetland does not exist within a designated FEMA floodplain. PEM Wetland(SP-1) measures approximately 0.001 acre in size within the project limits and is dominated by hydrophytic vegetation including common spikerush and woodrush flatsedge. PEM Wetland (SP-1) does not appear to have a hydrological connection to any waters of the U.S..

Based on the topography and aerial imagery, the majority of the site is typical for existing roadways with roadside ditches paralleling the road. The roadside ditches collectively drain into Harris County Flood Control District Unit Number U101-09-00. The wetlands were identified using the 1987 Manual regional supplement: Atlantic and Gulf Coastal Plain Region, which requires that all three wetland criteria be present under normal circumstances for areas to be determined a wetland. The wetland is a depressional area that experiences seasonal hydrology during and after rain events, providing the conditions necessary for wetlands to establish.

The nearest Waters of the U.S. (South Mayde Creek) is located approximately 3 miles east of PEM Wetland. PEM Wetland (SP-1) is not located in reasonable close proximity to any Waters of the U.S. As such, under normal conditions in the hydrologic cycle, the wetland would not be anticipated to share surface hydrology with the nearest Waters of the U.S. It is not tidal waters, nor part of any surface water tributary system to interstate water or navigable waters of the U.S. nor is it located "adjacent" (as defined in federal regulations) to any tributary waters; as such the wetland has been determined to be "isolated" as defined in federal regulations (33 CFR 330.2(e)).

"Adjacent" as per Federal regulations 33 CFR 328.3 is defined as "bordering, contiguous or neighboring." Wetlands separated from other Waters of the U.S. by man-made dikes or barriers, natural river berms, beach dunes and the like are 'adjacent wetlands.'" The nearest Waters of the U.S. to the wetland is South Mayde Creek. The wetland does not border nor is it contiguous (abutting) to South Mayde Creek. The wetland is not neighboring South Mayde Creek as determined by the fact that it is, under normal conditions in the hydrologic cycle, not located in reasonably close proximity to another Water of the U.S. (and is not located in the contiguous or bordering landscape position) that would have shared surface hydrology with another water of the U.S. during expected high flow (e.g. the 100-year floodplain). Nor is there any known demonstrable species ecological interconnection requiring the wetland in question and the nearest waters of the U.S. to spawn and/or fulfill the life cycle requirements. PEM Wetland (SP-1) is physically separated from other waters of the U.S. by geographic factors that does not allow the exchange of waters, via a confined surface hydrology connection during normal conditions and are not inseparably bound with South Mayde Creek.

"Isolated" waters as defined in 33 CFR 330.2(e) is: "those non-tidal waters of the U.S. that are: (1) not part of a surface tributary system to interstate or navigable waters of the U.S.; and (2) not adjacent to such tributary waterbodies." The wetland has been identified as a wetland (aquatic resource) that have been determined to be isolated.

"Waters of the U.S." are defined in 33 CFR 328.3(a) 1 thru 7 which is addressed in the following. Due to the fact that the wetland: (1) is not currently used, or was used in the past, nor susceptible to use for interstate or foreign commerce nor subject to the ebb and flow of the daily tide; (2) do not cross interstate or tribal boundaries; (3) the destruction of this wetland is not expected to affect (i)

interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or (iii) current use or potential use for industrial purposes by industries in interstate commerce; (4) are not impoundments of waters of the U.S.; (5) are not part of a surface tributary system of (a) (1) through (4); (6) are not part of the territorial seas; and (7) are not adjacent to waters of the U.S. identified in (a)(1) through (6) and this area (PEM Wetland (SP-1)) is not a water of the U.S.
