B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: There are no aquatic resources or potential aquatic resources in the review area that would

warrant the application of a wetland delineation, significant nexus analysis, navigability determination, and/or delineation of the ebb and flow of the tides. There are no features that have lateral limits of jurisdiction. (e.g., OHWM) Based on historical aerial imagery from Google Earth and topographic maps the proposed site has been used primarily for emergency service use for at least 20 years. Work involves the expansion of the Hidalgo Fire Station to include Conference/training room, fitness room, and bath/showers. The review area does not appear to have any apparent wetland signatures and lacks wetland parameters (hydric soils, hydrophytic vegetation, and wetland hydrology).
