C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Google Earth: areal imagery showed this area as an undeveloped parcel of land. The Frio River (RPW) flows through the project area and there are no indicators of saturation; however, a depression is visible within the review area. NWI Mapper indicates that a riverine feature is visible; however, no wetlands are indicated within the review area. The flood maps indicate that a portion of the review area is within the 100-year floodplain. The USDA Web Soil Survey indicates the soils within the review area consist of a Brundage fine sandy loam series consisting of very deep, moderately well drained, very slowly permeable soils that formed in saline loamy alluvium, a non-hydric soil, 0 to 2 percent slopes in the upland area and Buchel clay series consisting of very deep, very slowly permeable, moderately well drained soils that formed in calcareous clayey alluvium and is a hydric soil, 0 to 1 percent slopes, frequently flooded in the wetland area. Topographic map indicates a 6-foot drop within the wetland area from the upland area, and dense vegetation features are also indicated within the wetland portion of the review area. Topographic maps indicate that fill material was introduced between 1995 and 2005 within the upland area. A site visit was conducted on 11 October 2018 by the Corps. The temperature was in the high 80's F and overcast was present. The area has been significantly disturbed and fill materials placed within the upland area. An upland point (UP-1) was taken within an undisturbed area. Observed vegetation within the herb stratum included dominant species of Guinea grass (*Megathyrsus maximus*) and hairy seed paspalum (*Paspalum setaceum*) and yaupon holly (*Ilex vomitoria*) in the tree stratum. Soil observed has a 10 YR 4/1 with no redox visible. No hydrology was present within this data point. A wetland point (WP1) was taken within a depressional area. Observed vegetation consisted of *Juncus* (*Juncus albescens*), Johnson grass (*Sorghum halpen*) and cedar elm (*Ulmus crassifolia*). Soil observed has a 10 YR 4/1 and 10YR 5 /4 with 2 percent redox. Hydrological indicators consisted of algal mats, which is a primary indicator. WP-1 is adjacent to the Frio River and the soils appeared to be moist, but not saturated within the sample point. We have determined from the desktop review and the site visit that the lower portion of the project area does contain jurisdictional wetlands and the Corps has determined that these wetlands are Waters of the US, and that the RPW (Frio River) has a direct connection into a TNW (Nueces River) as defined under 33 CFR Part 328.3(a: 1-7) and could directly affect any waters of the U.S. with dredge or fill material. A Department of Army Permit will be required to discharge dredged or fill material on the project site.
