A. TNWs AND WETLANDS ADJACENT TO TNWs

The agencies will assert jurisdiction over TNWs and wetlands adjacent to TNWs. Summarize rationale supporting determination: The 2 September 1971 U.S. Army Corps of Engineers Galveston District Navigable Waters List reveals that Blind Bayou is navigable 3.8 miles from the confluence of Big Hill Reservoir. Blind Bayou is navigable in length 1.9 miles to Blind Lake and the rest of its length which is a total of 3.8 miles. This list includes Blind Lake (1.2 miles), Cabin Lake (0.4 miles) and Shallow Prong Lake (1.0 miles). Due to the fact that Big Hill Bayou is navigable in length of 10.5 miles, this includes the beginning of Big Hill Bayou at its confluence of Taylor Bayou (exhibited in the Port Acres USGS Quad) through Shallow Prong Lake and its termination at Big Hill Bayou (locally known as Right Prong). Locally known Left Prong, Right Prong, and Middle Prong (exhibited in the Big Hill Bayou Quad 1962 – Revised 1970-1974 USGS Quad) are navigable and identified as Big Hill Bayou and Shallow Prong Lake as it pertains to the 1971 2 September 1971 USACE Galveston District Navigable Waters List. Although Humble Cut is not on the above-mentioned list, Humble Cut is hydrologically connected to Cabin Lake and Blind Lake; therefore, extending the navigability laterally and connecting two waterbodies on the Navigable List and fully hydrologically connecting Cabin Lake to all of the other eight waterbodies. A determination of navigability, once made, applies laterally over the entire surface of the waterbody, and is not extinguished by later actions or events which impede or destroy navigable capacity (pg. 453 of the Code of Federal Regulations 33 Part 200 to End, Revised as of 1 July 2018 Navigation and Navigable Waters – Part 329). These eight waterbodies are navigable waters of the United States subject to Section 10 of the Rivers and Harbors Act (Section 10) and Section 404 of the Clean Water Act (Section 404) .

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on the desk review, Blind Bayou, Blind Lake, Cabin Lake, Shallow Prong Lake, Big Hill Bayou are all listed on the USACE Galveston District Navigable Waters List and are navigable waters of the United States subject to Section 10 of the Rivers and Harbors Act (Section 10) and Section 404 of the Clean Water Act (Section 404). Since locally known Left Prong, Right Prong, and Middle Prong are lateral extensions of Big Hill Bayou and Shallow Prong Lake and a continuous hydrologic connection to the above mentioned waterbodies (Big Hill Bayou and Shallow Prong Lake), they are considered navigable. Per the regulations, specifically, 33 CFR 329.4, navigable waters of the United States are those waters that are presently used, or have been used in the past, or may be susceptible for use to transport interstate or foreign commerce and/or are subject to the ebb and flow of the tide. The term “subject to the ebb and flow of the tide” is only a component or a tool to determine navigability. Tidal influences alone is not a sole determining factor in the determination of these waterbodies being deemed navigable. Section 10 regulates work and/or structures in navigable waters of the United States and Section 404 regulates the discharge of fill material into all waters of the United States. Therefore, work and/or structures and/or the discharge of fill material into Blind Bayou, Blind Lake, Cabin Lake, Shallow Prong Lake, the upstream portion of Big Hill Bayou (locally known as Right Prong), Big Hill Bayou, Humble Cut, the unnamed tributary to Big Hill Bayou (known locally as Middle Prong) and the unnamed tributary to Big Hill Bayou (locally known as Left Prong) requires a Department of the Army permit. This approved jurisdictional determination is valid for 5 years from the date of the notifying letter unless new information warrants a revision prior to the expiration date.
