WET3 (totaling approximately 4.8 acres) are "isolated" wetlands that are not hydrologically connected to any interstate or navigable waters of the U.S. WET1, WET2, and WET3 are wetlands but lack a nexus to interstate commerce and as such are not waters of the United States. 33 CFR 328

In conclusion, it is SWG draft determination that wetlands designated as WET1, WET2, and WET3 on the project site, totaling approximately 4.4 acres, are isolated (as per federal regulation) and lack a known nexus to interstate commerce. As such, the Galveston District draft determination that the subject wetlands are not subject to federal regulation under Section 404 of the Clean Water Act.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: There were three wetland polygons identified on the tract using the AGCP. WET1, WET2, and WET3 (totaling approximately 4.8 acres) are "isolated" wetlands that are not hydrologically connected to any interstate or navigable waters of the U.S. WET1, WET2, and WET3 are wetlands but lack a nexus to interstate commerce and as such are not waters of the United States. 33 CFR 328

- (1) WET1, WET2, and WET3 are not currently used, or were used in the past, nor are susceptible to use interstate or foreign commerce. WET1, WET2, and WET3 are not subject to the ebb and flow of the daily tide.
- (2) WET1, WET2, and WET3 do not cross interstate or tribal boundaries.
- (3) the destruction of WET1, WET2, and WET3 (intrastate wetlands) could not affect (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or, (iii) current use or potential use for industrial purposes by industries in interstate commerce.
- (4) WET1, WET2, and WET3 are not impoundments of waters of the United States.
- (5) WET1, WET2, and WET3 are not part of a surface tributary system of (a) (1) through (4).
- (6) WET1, WET2, and WET3 are not part of the territorial seas.
- (7) WET1, WET2, and WET3 are not adjacent to waters (other than waters that themselves are wetlands) identified in (a) (1) to (6). WET1, WET2, and WET3 have been determined by the Galveston District to not be adjacent, (bordering, contiguous, or neighboring) as defined by 33 CFR 328.3.(c) WET1, WET2, and WET3 are located outside of any 100-year floodplain of any water of the United States and do not have confined hydrological surface connections to any water of the United States.

WET1, WET2, and WET3 are "isolated" wetlands as defined in 33 CFR 330.2 (e) as: Isolated waters mean those non-tidal waters of the United States that are: (1) not part of a surface tributary system to interstate or navigable waters of the U.S., (2) not adjacent to such tributary waterbodies, and (3) that do not possess any known nexus to interstate commerce.

In conclusion, it is SWG draft determination that wetlands designated as WET1, WET2, and WET3 on the project site, totaling approximately 4.8 acres, are isolated (as per federal regulation) and lack a known nexus to interstate commerce. As such, the Galveston District draft determination that the subject wetlands are not subject to federal regulation under Section 404 of the Clean Water Act.
