C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The Drainage Swales 1 and 2, as defined by TCI, do not exhibit bed and bank, occur on nearly flat slopes, and have grass or other low-lying vegetation throughout the swale. Swales are generally not waters of the U.S. because they are not tributaries and/or they do not have a significant nexus to TNWs.

The "Erosion Feature" identified by the applicant's consultant in the swale downstream of Tributary A is a slightly depressed area within the swale, but does not display any wetland features or significant connection with Tributary A other than sheet flow. Tributary A is an erosional feature based on its appearance as seen in Google Earth Street View and the consultant's site photos, which show limited flow capacity, no visible ordinary high water mark, lack of any sediment sorting, and the presence of grass and other low-lying vegetation within the feature indicating minor water flow of infrequent and/or short duration. Google Earth Street View also did not show any evidence of significant stream function (e.g., presence of large woody debris, roots, leaf litter, wrack lines, sediment deposits); therefore, it is unlikely that Tributary A would have "more than a speculative or insubstantial effect on the chemical, physical and biological integrity" of Cayo Del Grullo, which eventually receives any discharge from this feature.

Pond 1 is the result of a man-made dike placed across Drainage Swale No. 1 for use in watering livestock. Pond 2 is also the result of a man-made dike placed across the drainage swale formed by the union of Drainage Swales Nos. 1 and 2 to provide water to livestock as its primary use. Since we do not find the drainage swales to be waters of the U.S., we also consider Ponds 1 and 2 to be non-jurisdictional. The two additional ponds (Ponds 3 and 4) are visible in Google Earth aerial photography, which verifies that both ponded areas are manmade and the result of excavating dry land to collect and retain water for watering livestock. Features of this type are generally not considered waters per 328.3(b)(4)(ii).
