B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE

REVIEW AREA ONLY INCLUDES DRY LAND: The review area contains 5 upland cut, man-made drainage ditches that was excavated prior to 1916 based upon a review of historic aerial photographs. These ditches are not a re-routed tributaries or extend the OHWM of a tributary. Additionally, these features undergo regular mowing and maintenance. Therefore, these features are not WOUS.
