those non-tidal waters of the U.S. that are not part of a surface tributary system to interstate or navigable water of the U.S., and are not adjacent to such tributary waterbodies. The two isolated water features (WF) within the review area have been determined not to be "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require any of the subject waters or the nearest waterbody (a water of the U.S. other than and adjacent wetland) to fulfill spawning and/or life cycle requirements. The two WFs appear to be depressional features in an area of low relief that only receive water through sheet flow after rainfall events. It is SWG's determination that the two isolated WFs are not waters of the US.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Chiltipin Creek is a relatively permanent waters of the U.S. that has been modified by dredging to accommodate stormwater input from the City of Sinton and water discharges from oil well production sites, which has created steep banks (approx. 20 feet). Dredged material from the creek was side cast onto the banks forming berms. The material on the northern bank has been graded into a road that also acts as a levee along the creek and poses a barrier to drainage features that empty into the creek. Historical aerial photography dating back to 1950 supports perennial flow of the creek. Ponds 1-5 appear to have originally been waters of the U.S. that were part of the Chiltipin Creek tributary system, which have become impounded due to the side cast material and to earthen barriers put in place to block flow in order to create stock tanks for livestock. Based on historical aerial photography, impoundment of these areas appears to have taken place between 1961 and 1975.

There are no known species in this georegion that require any of the subject waters or the nearest waterbody (a water of the U.S. other than and adjacent wetland) to fulfill spawning and/or life cycle requirements. The two WFs appear to be depressional features in an area of low relief that only receive water through sheet flow after rainfall events. It is SWG's determination that Isolated Wetlands 1 and 2 are not waters of the US.

Drainages 1 and 2 are both part of the Chiltipin Creek tributary system and would be considered First Magnitude tributaries of the creek. They remain connected to Chiltipin Creek via culverts through the berm barrier along the creek bank. The berm barrier does cause some ponding of water within these drainages that sustains fringe and emergent wetlands. The ponded waters and wetland areas are therefore considered adjacent to the creek, and therefore, jurisdictional waters of the U.S.

Drainage 3 is a ditch that has been excavated through what appears to be a drainage swale to consolidate sheet water flow during rainfall events to alleviate flooding. Historical aerial photography, including IR, does not show any of the parameters (hydric soils, hydrophytic vegetation, and wetland hydrology) necessary to be considered a wetland. In addition, this part of the review area did not have a confined hydrological surface connection to any water of the United States prior to being excavated. Per CFR 328.3 stormwater control features constructed to convey, treat, or store stormwater that are created in dry land are not considered waters of the US.
