C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: AR-1 (drainage ditch): Google Earth (GE) aerial photography indicates that AR-1 is a drainage ditch along an existing irrigation canal (Wilson Canal) and is primarily used to control stormwater during heavy rainfall from the Olmito Townsite Subdivision. The Hidalgo County Soil Survey Hydric Rating Map lists the following soil series within the review area as: Hidalgo Sandy Loam consisting of deep, well drained, moderately permeable soils that formed in calcareous loamy sediments and is classified as non-hydric soil; Racombes sandy clay loam series consisting of deep, moderately well drained, moderately permeable soils that formed in thick alkaline sediments; Willacy fine sandy loam consisting of deep, well drained, moderately permeable soils that formed in alkaline loamy sediments. All three soil series are considered as non-hydric soils. The NWI mapper does not indicate that the drainage ditch is an aquatic feature; however, the irrigation canal adjacent to the drainage ditch is classified as R5UBFx (excavated man-made feature) within the review area. Based on historical aerial imagery from GE the proposed site has been used primarily for residential stormwater drainage and lacks one or more of the three wetland parameters (hydric soils, hydrophytic vegetation, and wetland hydrology). There are no features that would extend the lateral limits of jurisdiction (e.g., OHWM). The proposed project (replacement of roadside ditches and culverts with the placement of approx. 1,264 linear feet of an underground 42-inch drainage pipeline to alleviate flooding within Olmito Townsite Subdivision) are not within jurisdictional waters of the US and are not subject to Section 404 of the CWA, or Section 10 of the Rivers and Harbors Act of 1899. Per 33 CFR 328.3(8)(b)(6)(AR-5) stormwater control features constructed to convey, treat, or store stormwater that are created in dry land are not considered jurisdictional waters of the US.
