information and our 2 Dec 2021 desk review, we have determined that Wetland A, is "isolated". This wetland was identified using the Atlantic and Gulf Coast Plain Region Supplement to the 1987 Wetland Delineation Manual. This wetland is depressional with precipitation as the primary source of hydrology. The nearest known water of the United States is Green Bayou. The wetland is 1.94 aerial miles east of Greens Bayou.

Based on our review, the wetland does not have a surface hydrologic connection to any water of the U.S. This wetland is not subject to the ebb and flow of the daily tide nor is currently used, or was used in the past, nor is susceptible to use for interstate or foreign commerce.

This wetland does not cross interstate or tribal boundaries.

The destruction of this intrastate wetland would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce.

This wetland is not an impoundment of water of the United States.

This wetland is not a tributary nor is it part of a tributary system.

This wetland is not part of the territorial seas.

This wetland is not "adjacent" (per Federal Regulations 33 CFR 328 (b) defines "adjacent" as bordering, neighboring, or contiguous to a water of the US).

This wetland is not part of prior converted cropland.

This wetland has been determined to be "isolated" per Federal Regulations. (33 CFR 330.2 (e): those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States nor adjacent to such tributary waterbodies). Based on the site review and floodplain maps, it was determined that the wetland is located above the anticipated high flow of any waterway (e.g., outside of the 100-year floodplain) and has no known nexus to interstate commerce. There are no known species in this georegion that require both the subject wetland and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements. As such this wetland is not "ecologically adjacent", as defined in the Rapanos as being "reasonably close" such that an ecologic interconnectivity is beyond speculation and insubstantial.

The wetland is located approximately 355 feet northwest of a drainage feature that runs to Greens Bayou, however, the 1916 (1-foot contour), 1944, 1954, 1967, and 1982 topographic maps do not show the drainage feature. The 1995 topographic map does show the drainage feature so the feature was constructed between 1982 and 1995. Therefore, we determined the feature is an upland drainage feature that only drains uplands.

In conclusion, it is the SWG draft determination that Wetland A is isolated and lacks a nexus to interstate commerce and as such is not a water of the United States and is not subject to federal regulation under Section 404 of the Clean Water Act.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
