Copano Bay is a secondary bay in the Aransas Bay system, which is listed on the Galveston District's List of Navigable Waters. Copano Bay is subject to the daily ebb and flow of the tide.

Under current circumstances the wetlands exhibit a predominance of hydrophytic vegetation, wetland hydrology, and hydric soils, as defined in the 1987 Corps of Engineers Wetland Delineation Manual and the Atlantic and Gulf Coastal Plain Regional Supplement (Version 2.0). Therefore, per 33 CFR 328.3(c) the wetlands are adjacent to the Copano Bay and subject to jurisdiction under Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: : A desktop review of the subject property was conducted on

September 5, 2019 to gather preliminary information, prior to a site visit. Google Earth (GE) aerial imagery taken in August 2019 indicates that the review area is adjacent to Copano Bay to the west and an access road (Northwest Drive) to the east. There are observable stream features that show a hydrological connection into the Copano Bay. GE aerial indicates that there are dark features within the review area. FEMA Panel 48391C0500D effective 09/26/2014 indicates the review area is in a coastal flood area. The National wetlands inventory mapper does not indicate any aquatic resources within the review area; however intertidal and estuarine and marine (E2EM1P) wetlands are present and directly adjacent to the review area. Web Soil Survey indicates the soils as Narta series consisting of very deep, poorly drained, very slowly permeable soils that formed in loamy fluviomarine sediments derived from the Beaumont Formation of Late Pleistocene age and is considered a hydric soil. These nearly level soils are on the South Texas Coastal Plain. These soils are subject to occasional flooding by high storm surge from strong tropical storms, and are ponded after periods of heavy rainfall. On 5 September 2019, the Corpus Christi Regulatory Field Office, represented by Wayne Fitzpatrick and Mr. Matthew Kimmel, conducted a site visit to determine if jurisdictional resources occur within the proposed project site. No transition of wetland vegetation to upland vegetation was observed. A wetland data point (WP-1) was taken within the review area. The vegetation observed consisted of 60 percent shore grass (*Monanthochloe littoralis*) (OBL) and 30 percent sea oxeye daisy (*Borrchia frutescens*) (OBL), 20 percent gulf cord grass (*Spartina spartinae*) (OBL) and 5 percent (*salicornia bigelovii*). Soils observed consisted of 0-16 inches 10 YR 4/1 depleted below dark surface (A11) with no visible redox concentration due to dark coloring of the soil. No upland point was available within the review area.
