C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: GE aeriels indicate that the majority of the proposed project (bike/hike trail) will be placed along existing trails and areas that are routinely maintained by the city of Harlingen. Based on the desktop review, it was determined that the review site is surrounded by undeveloped tracts of land to the south and golf course to the west and residential areas to the east. The location of (2) pedestrian walkways proposed are not located within the Section 10 navigable stretch of the Arroyo Colorado. NRCS Web Soil Survey indicates the soil as Mercedes-Urban land Complex series and is considered as a non-hydric soil. NWI mapper shows an aquatic feature (Arroyo Colorado) classified as a riverine lower perennial unconsolidated bottom (R2UBH) as the only aquatic feature within the review area. The review area is within the 100-year flood plain. Per CFR 328.3 (a) we determined that the Arroyo Colorado is a water of the US, specifically a surface water tributary and a Relatively Permanent Water that flows perennially into a TNW. Based on the applicant's description (i.e. constructing hike/bike trails along upland areas and the placement of (2) pedestrian walkways over the Arroyo Colorado) the proposed project would not have the effect of discharge of fill material into jurisdictional waters of the US, the activity does not require a Section 404 permit. The location of the walkways are not within the reach of the navigable waters within the Galveston District Regulatory Boundaries and are not Subject to Section 10 of the Rivers and Harbors Act of 1899.
