- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Based on off-site and on-site data collected during the site visit conducted on 10 February 2020, the aquatic resources (AR) within the review area are isolated and were determined to not be within Corps jurisdiction. The review area is approximately 135 acres in size. All of the AR do not show any observable connectivity to any other wetland, stream, or body of water that is in close proximity. There are no known hydrological connections between the review area and any other waters of the U.S. The nearest TNW (Port Bay) is 2.3 miles north of the project review area and there is no evidence that the feature drains into any other water feature. All of the AR within the review area are isolated and are not considered waters of the United States, as defined in 33 CFR 328.3(a). None of the AR within the review area are currently used, were used in the past, nor is susceptible to use for interstate or foreign commerce. None of the AR within the review area are subject to the ebb and flow of the daily tide. None of the the AR within the review area cross interstate or tribal boundaries. The destruction of these isolated wetlands, within the review area, would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce. None of the AR within the review area are impoundments of the waters of the U.S. None of the AR within the review area are part of a surface tributary system of any of the above. None of the AR within the review area are part of the territorial seas. None of the AR within the review area are adjacent to waters identified in any of the above. All of the AR within the review area have been determined NOT be adjacent, (bordering, contiguous, or neighboring) to a navigable water as defined by 33 CFR 328.3(c). All of the AR within the review areas are located outside of the 100-year flood plain of any water of the United States or a confined hydrological surface connection to any water of the United States. All of the AR within the review area are considered isolated waters as defined by 33 CFR 330.2 (e): those non-tidalwaters of the United States that are not part of a surface tributary system to interstate or navigable water of the United States, and is not adjacent to such tributary waterbodies. All of the AR within the review area have been determined not to be "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require either of the subject waters or the nearest waterbody (a water of the United States other than and adjacent wetland) to fullfill spawning and/or life cycle requirements.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

ADDITIONAL COMMENTS TO SUPPORT JD: Based on off-site and on-site data collected during the site visit conducted on 10 February 2020, the aquatic resources (AR) within the review area are isolated and were determined to not be within Corps jurisdiction. The review area is approximately 135 acres in size. All of the AR do not show any observable connectivity to any other wetland, stream, or body of water that is in close proximity. There are no known hydrological connections between the review area and any other waters of the U.S. The nearest TNW (Port Bay) is 2.3 miles north of the project review area and there is no evidence that the feature drains into any other water feature. All of the AR within the review area are isolated and are not considered waters of the United States, as defined in 33 CFR 328.3(a). None of the AR within the review area are currently used, were used in the past, nor is susceptible to use for interstate or foreign commerce. None of the AR within the review area are subject to the ebb and flow of the daily tide. None of the the AR within the review area cross interstate or tribal boundaries. The destruction of these isolated wetlands, within the review area, would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce. None of the AR within the review area are impoundments of the waters of the U.S. None of the AR within the review area are part of a surface tributary system of any of the above. None of the AR within the review area are part of the territorial seas. None of the AR within the review area are adjacent to waters identified in any of the above. All of the AR within the review area have been determined NOT be adjacent, (bordering, contiguous, or neighboring) to a navigable water as defined by 33 CFR 328.3(c). All of the AR within the review areas are located outside of the 100-year flood plain of any water of the United States or a confined hydrological surface connection to any water of the United States. All of the AR within the review area are considered isolated waters as defined by 33 CFR 330.2 (e): those non-tidalwaters of the United States that are not part of a surface tributary system to interstate or navigable water of the United States, and is not adjacent to such tributary waterbodies. All of the AR within the review area have been determined not to be "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require either of the subject waters or the nearest waterbody (a water of the United States other than and adjacent wetland) to fullfill spawning and/or life cycle requirements.
