MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹SWG-2019-00769

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in Texas due to litigation.

3. REVIEW AREA. The property is located at 4231 13 Mile Road in Galveston, Galveston County, Texas. The center coordinates for Wet A are 29.196540°, -94.948900°. 5. Wet A was evaluated as part of an AJD request completed on 22 January 2020. The applicant asked for Wet A to be evaluated under the pre-2015 regime post Sackett guidance.

Based on our desk review, Wet A does not have any known continuous surface connection to the Gulf of Mexico, West Galveston Bay, or any other water of the United States (See Attached Maps). Wet A is adjacent to dune swale wetlands as seen in aerial photography. These wetlands extend east and west of the wetlands adjacent to Wet A. However, based on aerial photography and LiDAR, these wetlands do not have a continuous surface connection to a water of the United States. Therefore, Wet A does not meet the definition of adjacent as defined in the pre-2015 regime post *Sackett* guidance and is not a water of the United States subject to Section 404 of the Clean

Water Act. Any discharge of dredge and/or fill material into this wetland does not require a Department of the Army permit.
