Explain: **Based on a review of available information and our desk review, we have determined that there are three aquatic features on the site: Open Water 1 (OW1 ~ 4.6 acres), Open Water 2 (OW2 ~ 0.4 acre) and Open Water 3**

(OW3 ~ 0.3 acre). These features are all located in an "isolated" landscape position. They total approximately 5.3 acres and are comprised mostly of open water and have an estimate of 0.1 acre of fringe wetlands. These aquatic features appear to be excavated from uplands resulting from excavated borrowed material to be used in association with the KCS yard expansion project completed in 2015. It is also noted that feature labeled OW2 is currently being used as a storm water retention/treatment pond for the railyards stormwater which enters the pond via sub-surface drainage system and drain inlets within the concrete parking area along the north side of the yard. The subsurface drainage system conveys storm water into the pond near the southeast corner of the pond. Wetlands were identified off-site information using the Atlantic Gulf Coastal Plain Region Supplement to the 1987 Wetland Delineation Manual. The nearest known navigable water of the United States is the Colorado River and these aquatic features are located approximately 13.6 miles away. Based on our review, none of these subject aquatic features have a surface hydrologic connection to any known water of the U.S. (nearest is Turkey Creek located ~ 1500+' away at the closest edge).

These subject aquatic features are not subject to the ebb and flow of the daily tide nor is not currently used, or was used in the past, nor is susceptible to use for interstate or foreign commerce.

These subject aquatic features do not cross interstate or tribal boundaries.

The destruction of this intrastate subject aquatic features would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce.

These subject aquatic features are not an impoundment of water of the United States.

These subject aquatic features are not a tributary nor was it part of a tributary system.

These subject aquatic features are not part of the territorial seas.

These subject aquatic features are not "adjacent" (per Federal Regulations 33 CFR 328 (b) defines "adjacent" as bordering, neighboring, or contiguous to a water of the US).

These subject aquatic features are not part of a prior converted cropland.

These subject aquatic features have been determined to be "isolated" per Federal Regulations. (33 CFR 330.2 (e): those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States nor adjacent to such tributary waterbodies). Based on the site review and floodplain maps, it was determined that these subject aquatic features are located above the anticipated high flow of any waterway (e.g., outside of the 100-year floodplain) and these subject aquatic features have no known nexus to interstate commerce associated with them. There are no known species in this georegion that require both the subject aquatic features and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements. As such these subject aquatic features are not "ecologically adjacent", as defined in the Rapanos as being "reasonably close" such that an ecologic interconnectivity is beyond speculation and insubstantial.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Based on a review of available information and our desk review, we have determined that there are three aquatic features on the site: Open Water 1 (OW1 ~ 4.6 acres), Open Water 2 (OW2 ~ 0.4 acre) and Open Water 3 (OW3 ~ 0.3 acre). These features are all located in an "isolated" landscape position. They total approximately 5.3 acres and are

comprised mostly of open water and have an estimate of 0.1 acre of fringe wetlands. These aquatic features appear to be excavated from uplands resulting from excavated borrowed material to be used in association with the KCS yard expansion project completed in 2015. It is also noted that feature labeled OW2 is currently being used as a storm water retention/treatment pond for the railyards stormwater which enters the pond via sub-surface drainage system and drain inlets within the concrete parking area along the north side of the yard. The subsurface drainage system conveys storm water into the pond near the southeast corner of the pond. Wetlands were identified off-site information using the Atlantic Gulf Coastal Plain Region Supplement to the 1987 Wetland Delineation Manual. The nearest known navigable water of the United States is the Colorado River and these aquatic features are located approximately 13.6 miles away. Based on our review, none of these subject aquatic features have a surface hydrologic connection to any known water of the U.S. (nearest is Turkey Creek located ~ 1500+' away at the closest edge).

These subject aquatic features are not subject to the ebb and flow of the daily tide nor is not currently used, or was used in the past, nor is susceptible to use for interstate or foreign commerce.

These subject aquatic features do not cross interstate or tribal boundaries.

The destruction of this intrastate subject aquatic features would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce.

These subject aquatic features are not an impoundment of water of the United States.

These subject aquatic features are not a tributary nor was it part of a tributary system.

These subject aquatic features are not part of the territorial seas.

These subject aquatic features are not "adjacent" (per Federal Regulations 33 CFR 328 (b) defines "adjacent" as bordering, neighboring, or contiguous to a water of the US).

These subject aquatic features are not part of a prior converted cropland.

These subject aquatic features have been determined to be "isolated" per Federal Regulations. (33 CFR 330.2 (e): those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States nor adjacent to such tributary waterbodies). Based on the site review and floodplain maps, it was determined that these subject aquatic features are located above the anticipated high flow of any waterway (e.g., outside of the 100-year floodplain) and these subject aquatic features have no known nexus to interstate commerce associated with them. There are no known species in this georegion that require both the subject aquatic features and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements. As such these subject aquatic features are not "ecologically adjacent", as defined in the Rapanos as being "reasonably close" such that an ecologic interconnectivity is beyond speculation and insubstantial.

In conclusion, it is SWG's draft determination that these isolated aquatic features are not a water of the United States and are not subject to Section 404 of the Clean Water Act.
