Explain: **The review area consists of drainage ditches created to alleviate flooding within the Anaquitas Drainage. Work primarily involves the installation culvert boxes, concrete headwalls, and a stormwater pump station within the existing drainage ditches. The upgrades to the drainage ditch will convey storm water run-off into a man-made canal to the south. There are no features that have lateral limits of jurisdiction (e.g., OHWM). Based on historical aerial imagery from Google Earth the proposed site has been used primarily for residential stormwater drainage and lacks any wetland parameters (hydric soils, hydrophytic vegetation, and wetland hydrology). The review area does have a confined hydrological surface connection to waters of the United States (Arroyo Colorado). However, the drainage ditches are not historical stream beds or creeks and constructed from uplands within an urban area. The proposed project will add new pavement to existing paved roads within the ROW above the outfall structures. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

However, the drainage ditches are not historical stream beds or creeks and constructed from uplands within an urban area. The proposed project will add new pavement to existing paved roads within the ROW above the outfall structures. Per CFR 328.3(8)(b)(6) stormwater control features constructed to convey, treat, or store stormwater that are created in dry land are not considered waters of the US.
