Drainage A, Drainage C, and Roadside Drainage are man-made drainage ditches with non-permanent flow that does not exhibit a direct hydrologic connection to a WOTUS and appeared to have been constructed wholly in uplands and drain only in uplands. These resources are not regulated pursuant to the 1986 preamble and does not meet any definitions under 33 CFR 328.3. They include erosional features (gullies and rills), and swales and ditches that are not tributaries or wetlands.

Ponds H is man-made pond that was constructed within uplands; would not be considered impoundments of jurisdictional waters, is not in the floodplain of the nearest TNW, has no hydrological connection to any jurisdictional waters or wetlands in the area, and does not meet the definition of waters” as defined in federal regulations (33 CFR 328.3)).

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
