**C. Additional comments to support AJD:** No wetlands were observed at the project site. One man-made ditch was observed which was constructed in uplands adjacent to a railroad embankment. An approved jurisdictional determination for the abutting property to the south was completed 2 November 2020 (SWG-2018-00875). All aquatic features were determined to be excluded waters or features under the 33 CFR 328 (b) exclusions.
