property and are surrounded by uplands. The wetlands were identified using the Atlantic and Gulf Coastal Plain Region Supplement of the 1987 Corps of Engineers Wetland Delineation Manual which under normal circumstances exhibits a dominance of hydrophytic vegetation, wetland hydrology indicators, and hydric soils. The nearest known water of the United States is an unnamed tributary, a relatively permanent water that flows into Dickson Bayou, the nearest traditional navigable water, approximately 3.2 river miles downstream. The wetlands are located .06 miles north of the unnamed tributary.

Based on the desk review conducted 21 February 2023, there are no known hydrological connections between the wetlands and the unnamed tributary. A review of the FIRM FEMA map shows the wetlands are outside of the FEMA 100-year floodplain of any water of the United States, including the unnamed tributary and Dickinson Bayou. There are no confined hydrologic connections between the wetlands and any water of the United States determined by off-site data and the delineation report. The wetlands are not adjacent to any waters of the United States as defined by 33 CFR 328.3(c).

The wetlands are isolated and are not waters of the United States, as defined in 33 CFR 328.3(a). Isolated waters are defined in 33 CFR 330.2(e) as those non-tidal waters that are: (1) Not part of a surface tributary system to interstate or navigable waters of the United States; and (2) Not adjacent to such tributary waterbodies.

- The wetlands are not currently used, were not used in the past, nor may be susceptible to use in interstate or foreign commerce.
 - These wetlands are not subject to the ebb and flow of the daily tide, nor are they part of a territorial sea.
 - They do not cross interstate or tribal boundaries.
- The wetlands are "isolated" and do not currently nor were they in the past associated with affecting (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or, (iii) current use or potential use for industrial purposes by industries in interstate commerce.
 - The wetlands are not an impoundment of water of the United States.
 - The wetlands are not, nor were they ever, part of a surface tributary system.
 - The wetlands are not "adjacent" (as defined by federal regulations) to any other water of the US.
- The wetlands were determined not to be "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this geographic region that require both the subject wetlands and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements. In conclusion, it is SWG draft determination that the wetlands on the tract, totaling approximately 5.2 acres, are isolated (as per federal regulation) and do not possess any known nexus to interstate commerce. As such, the Galveston District determined the wetlands are isolated and not subject to federal regulation under Section 404 of the Clean Water Act (Section 404).

The project site contains 1 upland drainage ditch, (Ditch 1) totaling approximately 2,617-linear feet (0.1-acre) and 1 pond (Pond 1) totaling approximately 0.15-acre. The drainage ditch was excavated from uplands, does not reroute a tributary, and does extend the ordinary high water mark of any known Waters of the United States. Pond 1 was excavated from uplands for aesthetic purposes. We determined that Ditch 1 and Pond 1 are not waters of the United States and are not subject to Section 404.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
