Wetlands WET 001-A, WET 001-B, WET 002-A and WET 002-B are all contiguous and abut the East End Lagoon, a TNW; therefore, these are adjacent wetlands to a TNW subject to Section 10 and Section 404.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on our 11 February 2022 site visit and desk review, we determined the approximate 186-acre tract contains seven aquatic features comprising 169.11-acres (WET 001-A -11.9 acres, WET 001-B – 121 acres, WET 002-A – 2.09 acres, WET 002-B – 3.24 acres, WET 003 – 0.40 acre, WET 004 – 0.10 acre, OPEN WATER 001– 30.38 acres), specifically wetlands adjacent and abutting the Galveston Ship Channel, a Traditional Navigable Water (TNW), and a tidal lagoon. The Galveston Ship Channel, a TNW, is currently used in interstate and foreign commerce and is subject to the ebb and flow of the tide and as such is a navigable water of the United States subject to Section 10 of the Rivers and Harbors Act of 1899 (Section 10) and Section 404 of the Clean Water Act (Section 404). Wetlands 003 and 004 lie wholly within the 100-year floodplain associated with the Galveston Ship Channel; and therefore, are adjacent to a TNW and subject to Section 404. Wetlands WET 001-A, WET 001-B, WET 002-A and WET 002-B are all contiguous and abut the East End Lagoon, a TNW; therefore, (WET 003, WET 004, WET 001-A, WET 001-B, WET 002-A, WET 002-B and OPEN WATER 001) are waters of the U.S. and any work in/or affecting these waters are subject to Section 10 of the Rivers and Harbors Act and Section 404 of the Clean Water Act and requires a Department of the Army permit. .
