B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: The review area is not located within an historic aquatic feature and is wholly within the uplands. There are no aquatic resources or potential aquatic resources in the review area that would warrant conducting a wetland delineation,

significant nexus analysis, navigability determination, and/or delineation of the ebb and flow of the tides. There are no features that have lateral limits of jurisdiction. (e.g., OHWM) Based on historical aerial imagery from Google Earth and topographic maps the proposed drainage improvement site consists of drainage ditches excavated within the uplands that have been used primarily for storm run-off. Work involves the excavation of a detention pond at the corner of Highway 77 and Mulberry Rd. and a linear detention pond using reinforced concrete pipes and continuing eastward toward US Highway 77 for drainage improvements within Willacy County. The drainage ditches are not historical aquatic features and appear to be man-made excavations that were made wholly within the uplands.
