C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Explain: They include erosional features (gullies and rills), and swales and ditches that are not tributaries or wetlands. The project site contains two upland, drainage ditches: Drainage Ditch 1 (1,806 LF) and Drainage Ditch 2 (923 LF) that are stormwater features and are non-jurisdictional based on 33 CFR 328.5. Based on the topography and aerial imagery, the majority of the site is level, with gradual sloping towards Spring Gully and Greens Bayou southwest of the project site. These wetlands were verified during the August 3, 2021, site visit using the 1987 Manual Regional Supplement: Atlantic and Gulf Coastal Plain Region, which requires that all three wetland criteria be present under normal circumstances for an area to be determined a wetland. These wetlands are depressional and experiences seasonal hydrology during and after rain events, providing the conditions necessary for a wetland to establish.

Wetlands 01 through 03 are located outside of the 100-year floodplain of any water of the United States, including Spring Gully or Greens Bayou. Wetlands 02 and 03 do lie within the 100-year floodplain of HCFCD DitchP107-02-00, however that feature was determined to be an upland ditch and not a water of the U.S. Wetlands 01 through 03 are not an impoundment of jurisdictional water; and have no hydrological surface connection to any jurisdictional waters.

"Isolated" waters as defined in 33 CFR 330.2 (e) is: "those non-tidal Waters of the U.S. that are: (1) not part of a surface tributary system to interstate or navigable Waters of the U.S.; and (2) not adjacent to such tributary waterbodies." Wetlands 01 through 03 have been identified as an aquatic resource and have been determined to be isolated.
